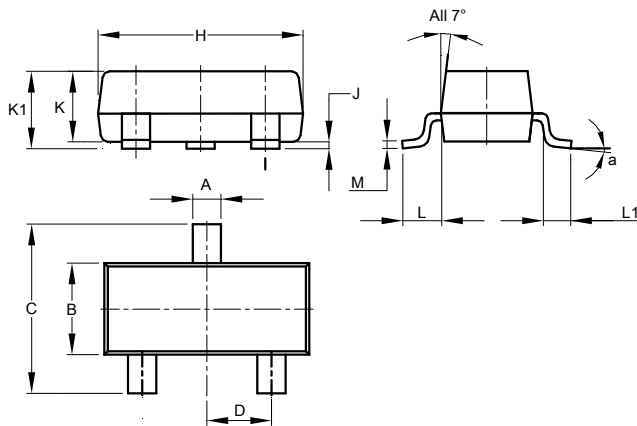


MAXIMUM TRANSIENT THERMAL RESISTANCE*

Package Outline Dimensions

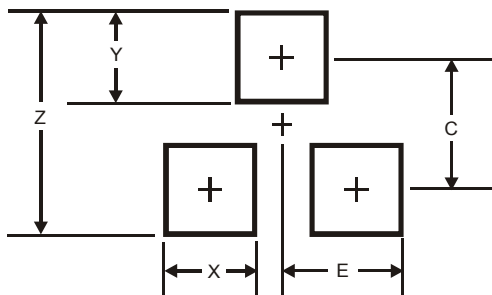
