



4. Functional diagram










Fig 8. Package outline SOT163-1 (SO20)





Fig 9. Package outline SOT339-1 (SSOP20)




Fig 10. Package outline SOT724-1 (SSOP20)





Fig 11. Package outline SOT360-1 (TSSOP20)
