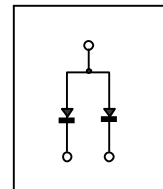

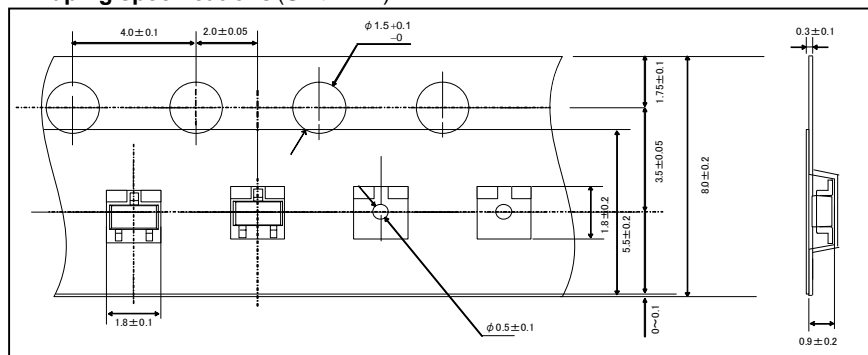

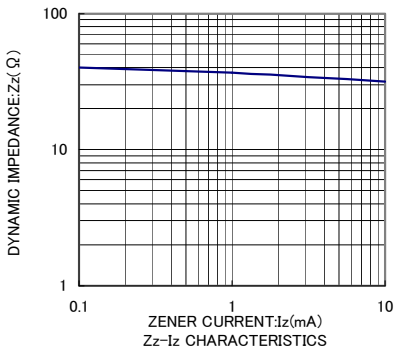
V_z DISPERSION MAP
