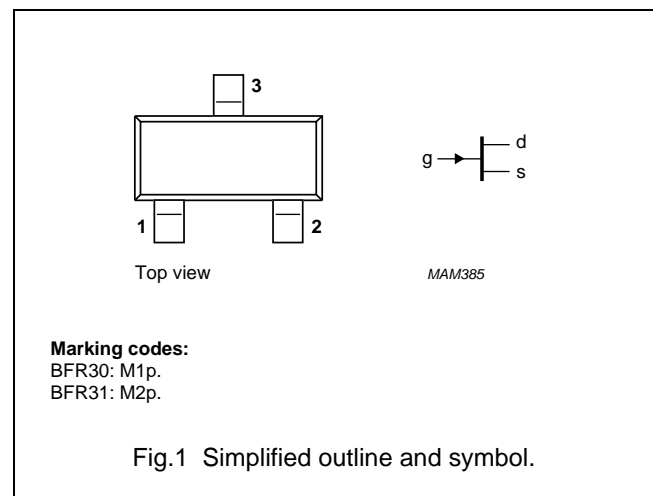

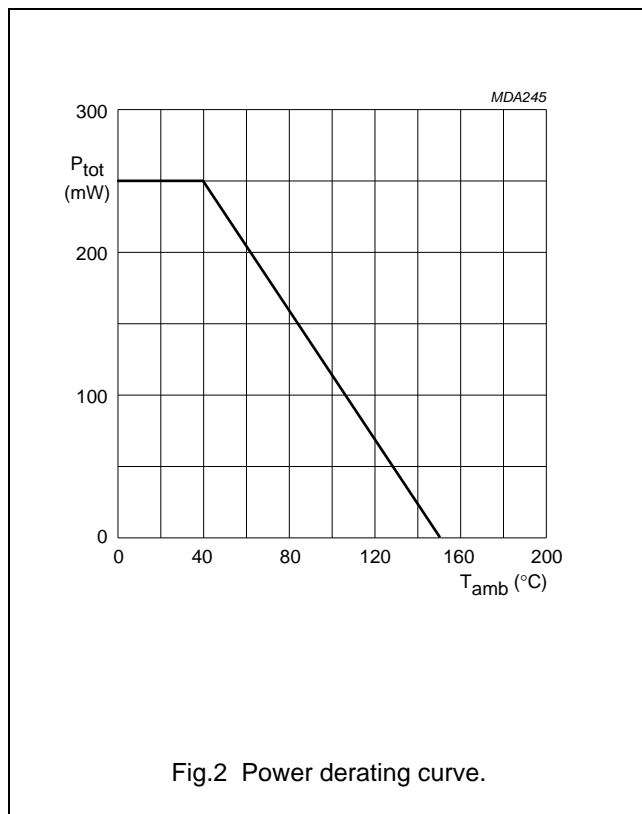


Fig.2 Power derating curve.
