




Fig. 1 - Reverse Dark Current vs. Ambient Temperature





Fig. 2 - Relative Reverse Light Current vs. Ambient Temperature

Fig. 3 - Reverse Light Current vs. Irradiance




Fig. 4 - Reverse Light Current vs. Reverse Voltage




Fig. 5 - Diode Capacitance vs. Reverse Voltage




Fig. 6 - Relative Spectral Sensitivity vs. Wavelength





Fig. 7 - Relative Radiant Sensitivity vs. Angular Displacement

#### **PACKAGE DIMENSIONS** in millimeters



#### TAPE AND REEL DIMENSIONS in millimeters



#### DRYPACK

Devices are packed in moisture barrier bags (MBB) to prevent the products from moisture absorption during transportation and storage. Each bag contains a desiccant.

#### FLOOR LIFE

Time between soldering and removing from MBB must not exceed the time indicated in J-STD-020: Moisture sensitivity: Level 4 Floor life: 72 h Conditions:  $T_{amb} < 30$  °C, RH < 60 %

#### DRYING

In case of moisture absorption devices should be baked before soldering. Conditions see J-STD-020 or recommended conditions:

192 h at 40 °C (+ 5 °C), RH < 5 % or 96 h at 60 °C (+ 5 °C), RH < 5 %.
