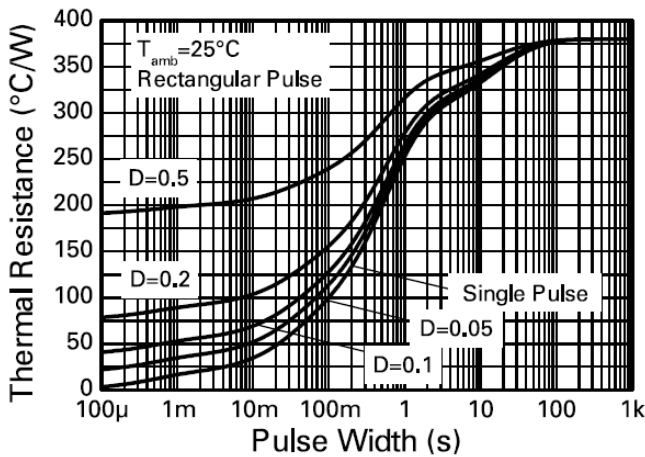

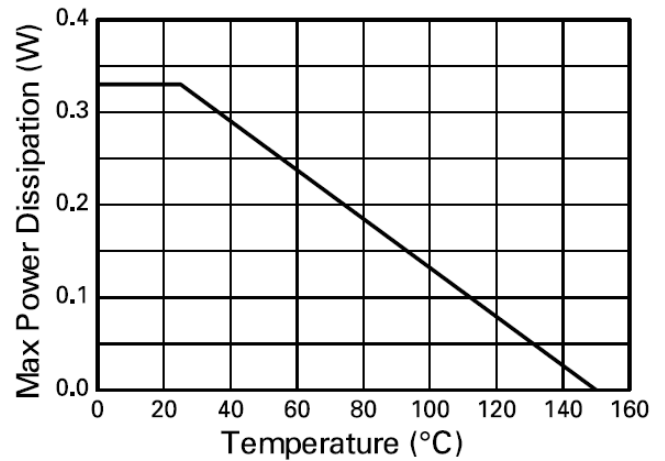

Derating Curve

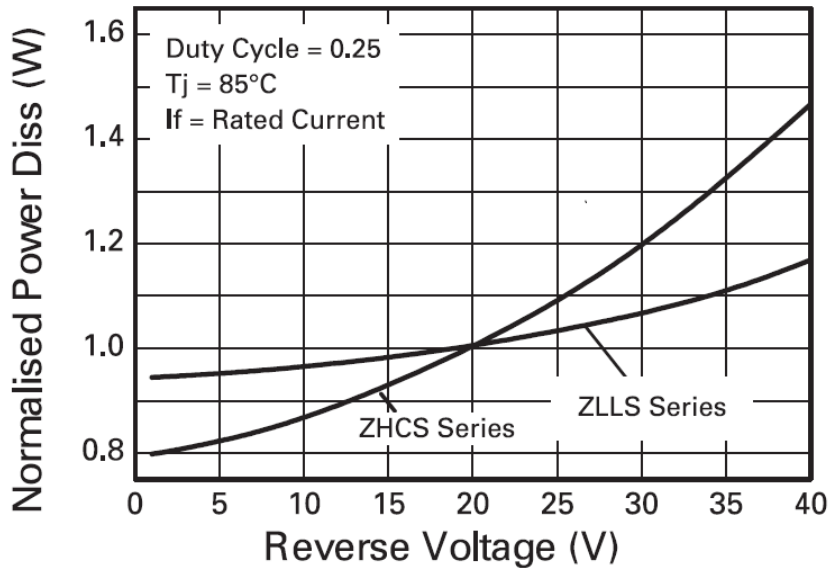

Operational Efficiency Example

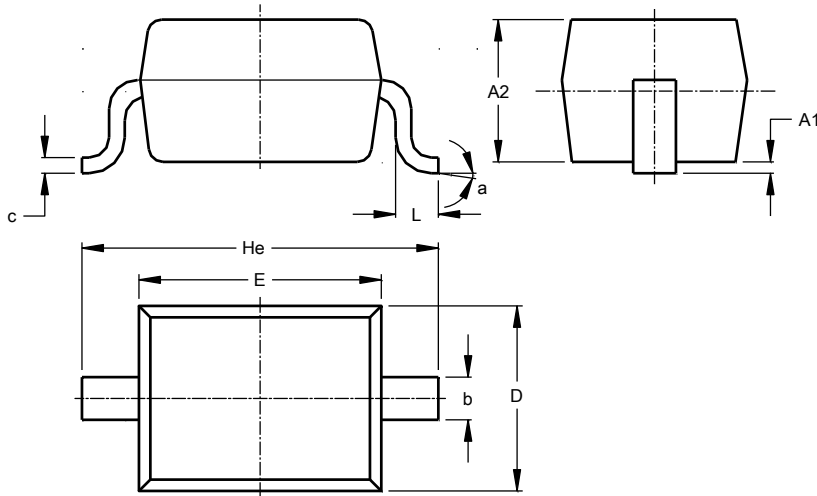

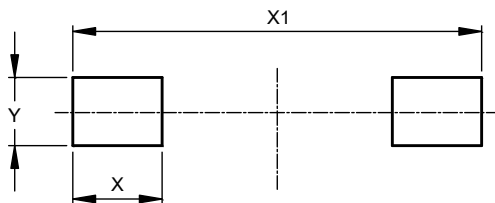
