


Internal Structure of MBR2060C








Figure 1. Typical Forward Voltage




Figure 2. Typical Reverse Current





Figure 3. Average Rectified Forward Current vs.


Case Temperature (Per Diode)








Package Outline Dimensions (Cont. All dimensions in mm(inch).)
