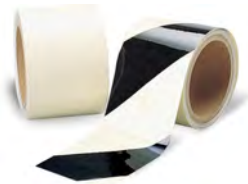

Labeling is required for infectious substances which meets one or more hazard classifications.

UN2814 Infectious Substances:

Ebola virus defined as Category A infectious substance.
