

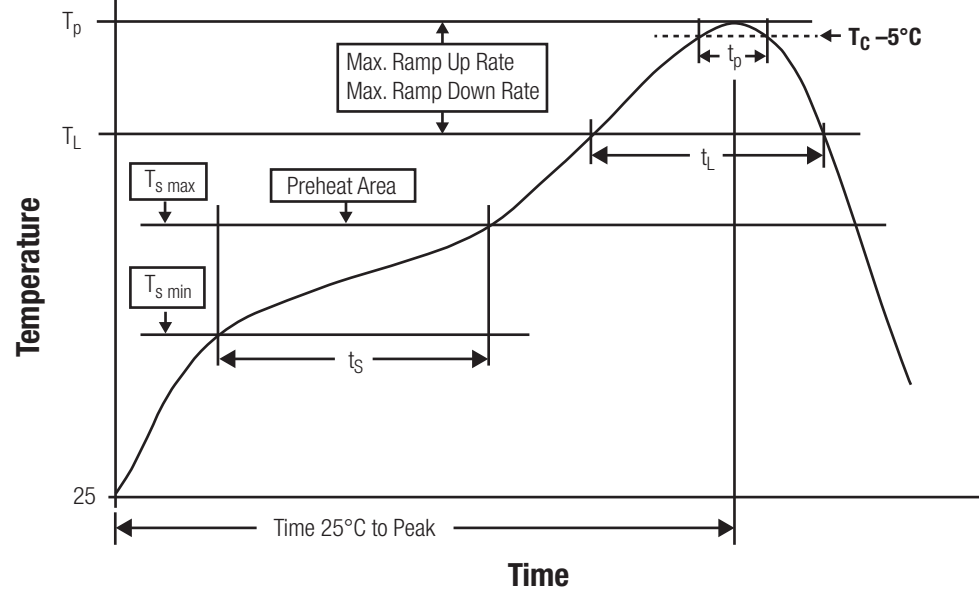


### Cleaning and Washing:


