

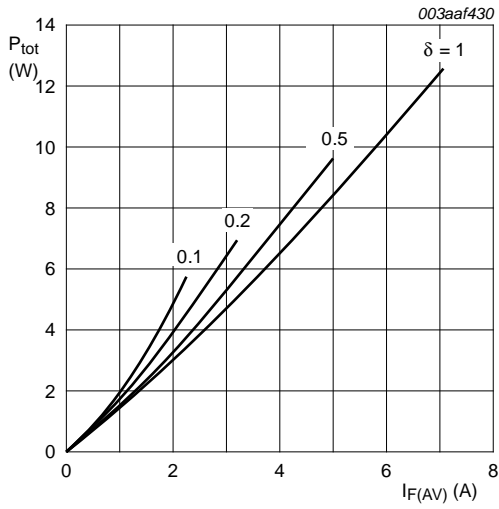

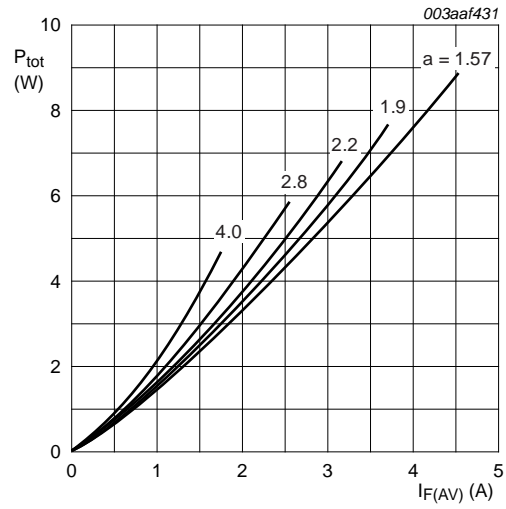

Fig 2. Forward power dissipation as a function of average forward current; sinusoidal waveform; maximum values

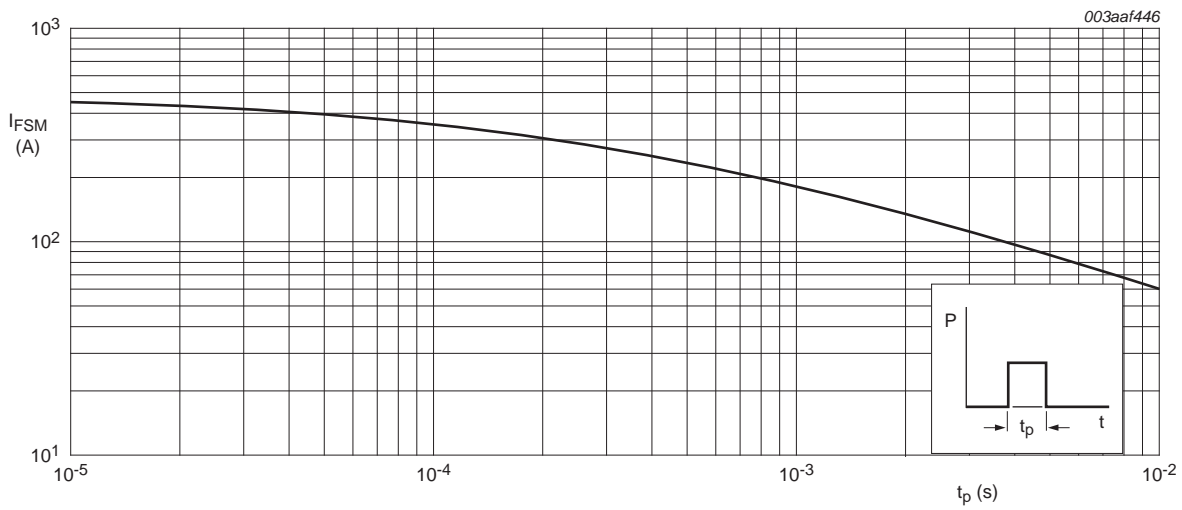


Fig 3. Non-repetitive peak forward current as a function of pulse width; square waveform; maximum values

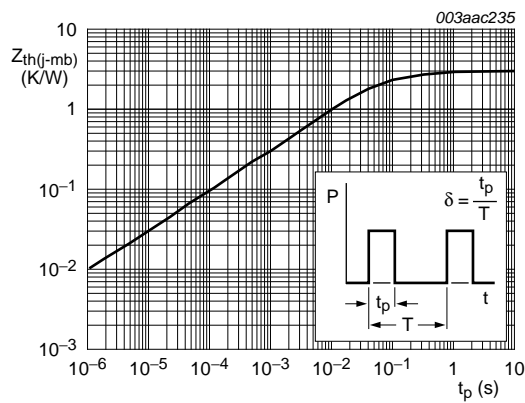
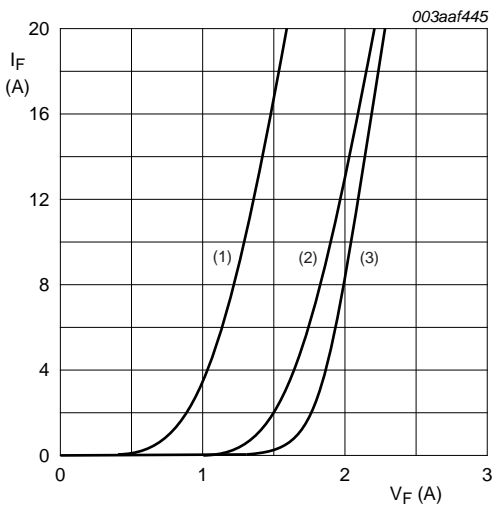


Fig 4. Transient thermal impedance from junction to mounting base as a function of pulse width

Fig 5. Forward current as a function of forward voltage

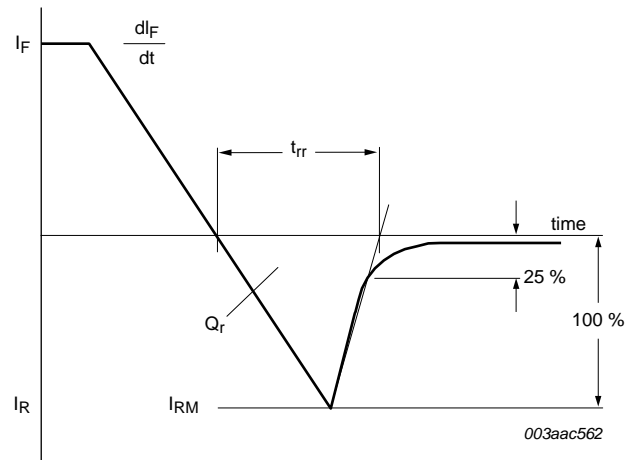


Fig 6. Reverse recovery definitions; ramp recovery

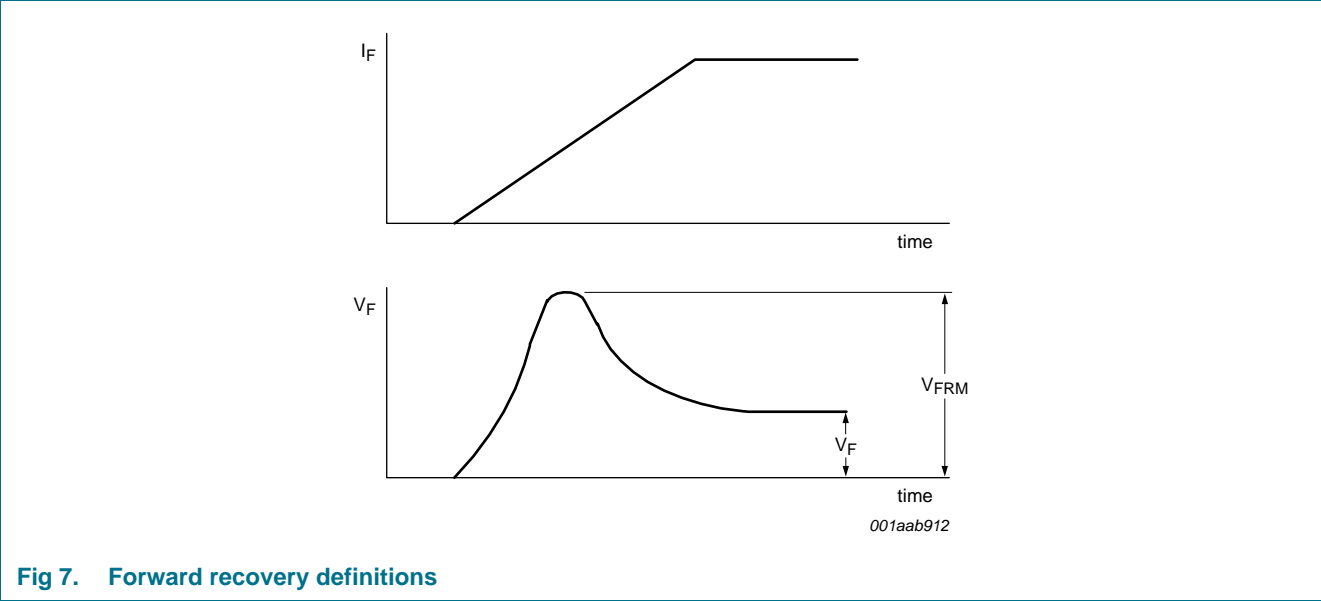


Fig 7. Forward recovery definitions

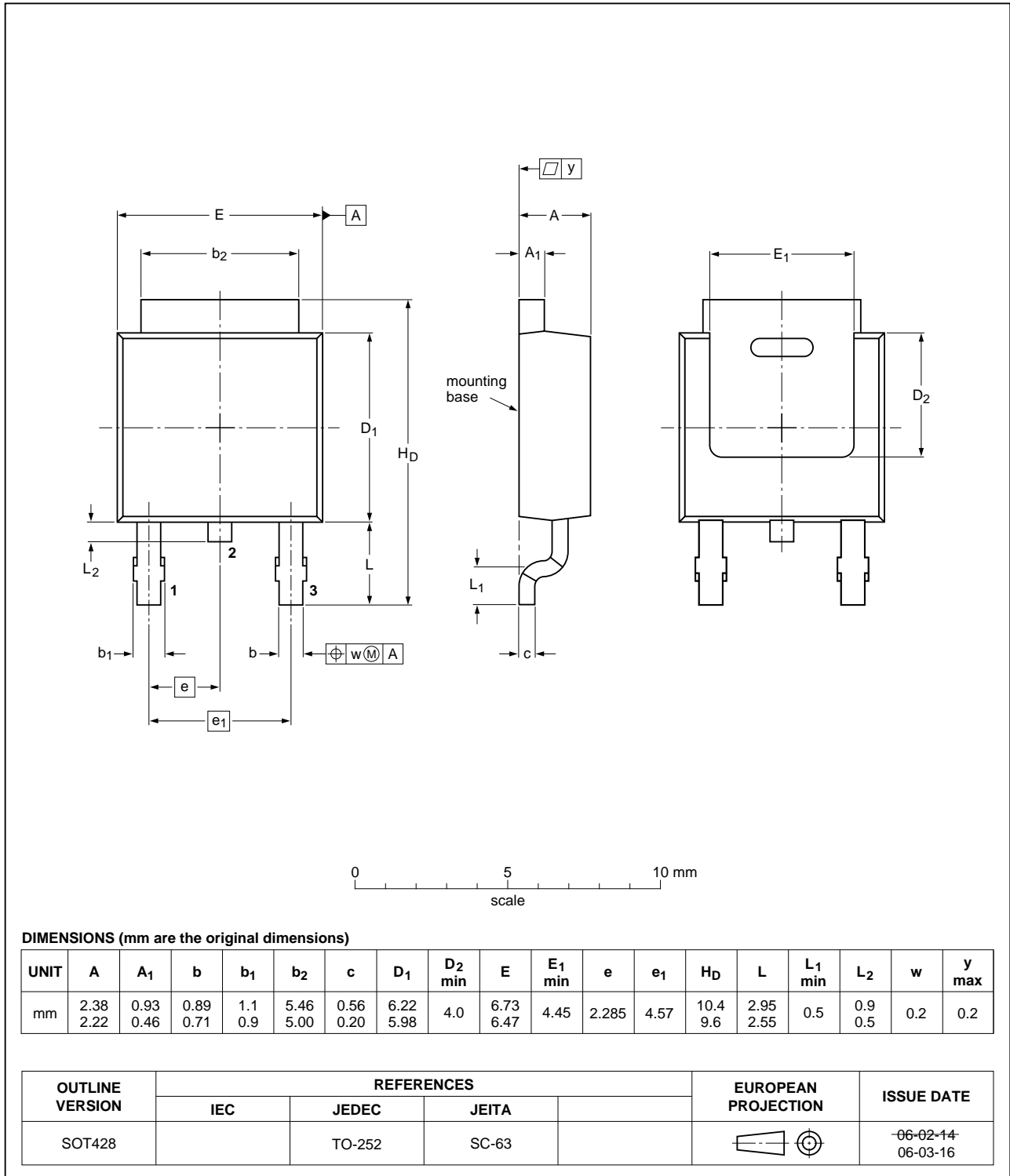


Fig 8. Package outline SOT428 (DPAK)

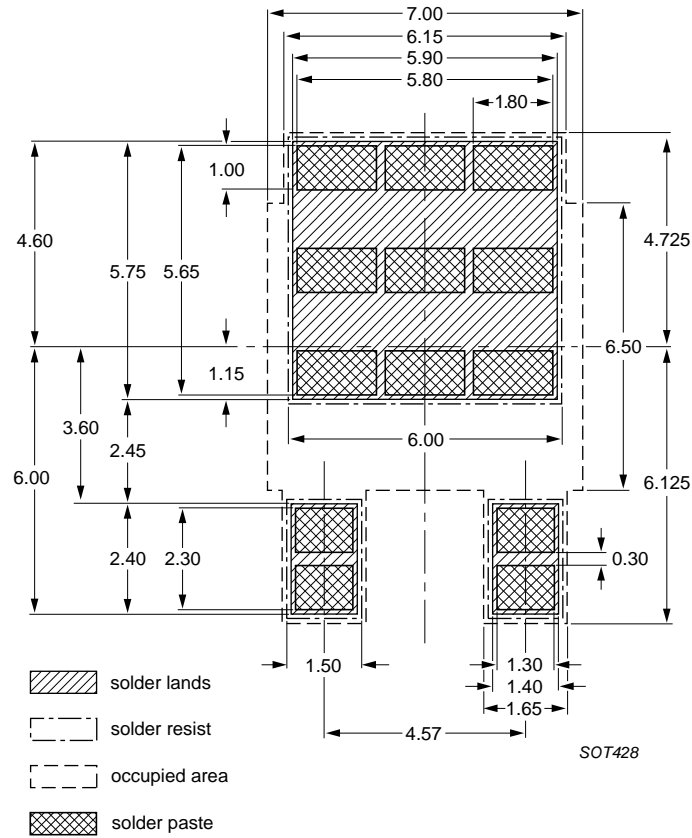


Fig 9. Reflow soldering footprint for SOT428 (DPAK)
