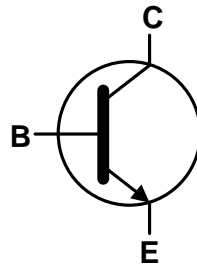

Description

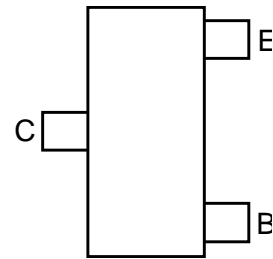

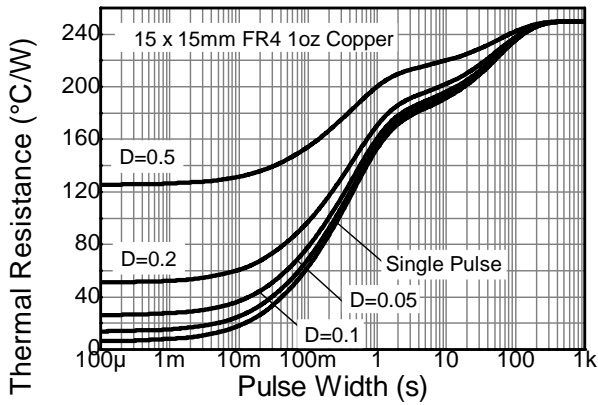

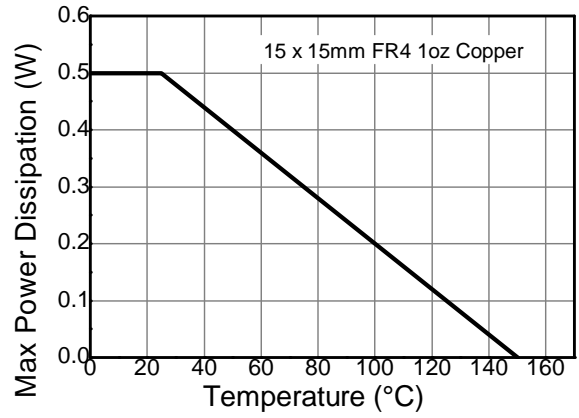

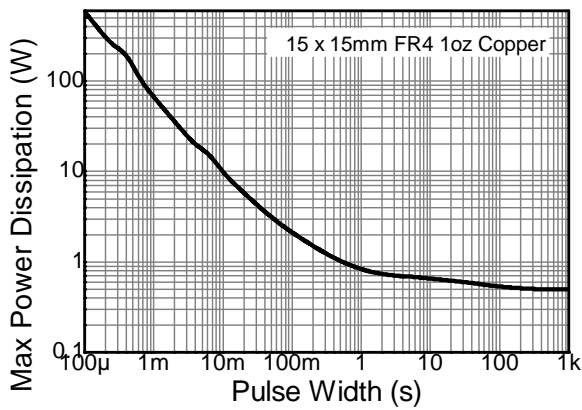
Thermal Characteristics and Derating Information

Derating Curve



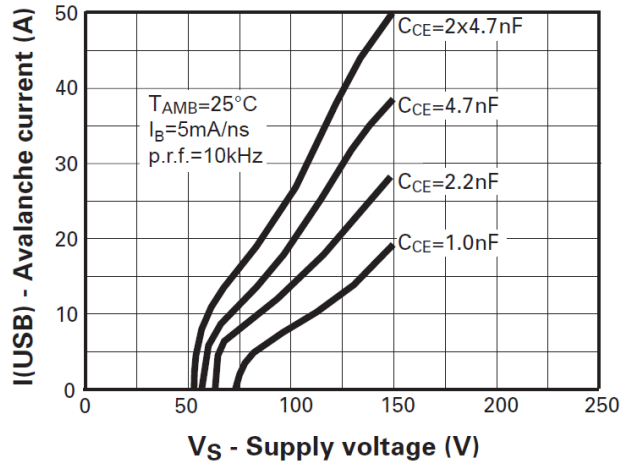

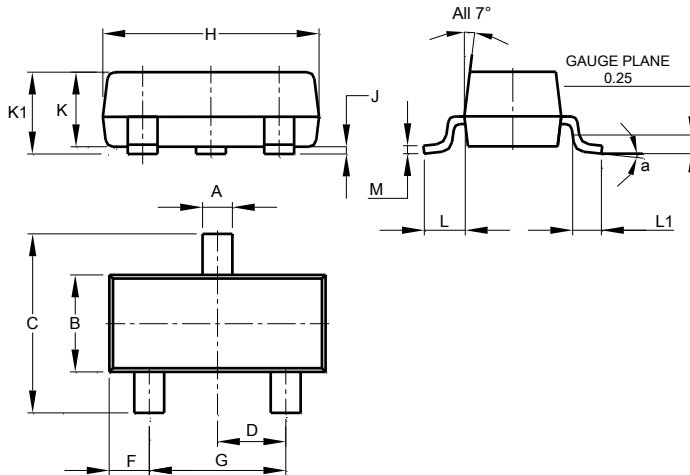

Package Outline Dimensions

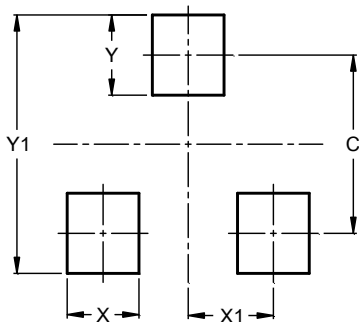
