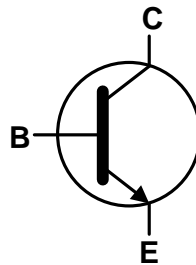

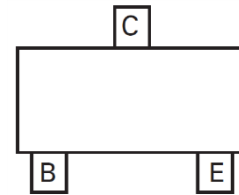

Device Symbol



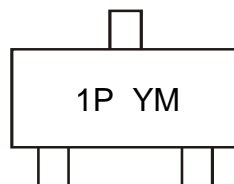
Pin-out Top View

Package Outline Dimensions

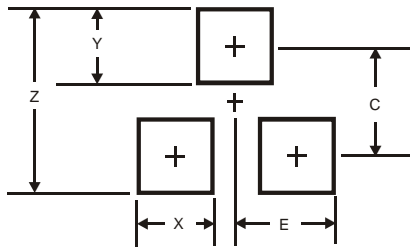
