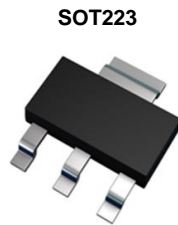

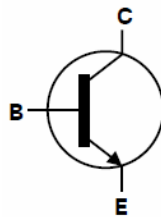

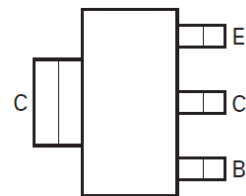

Device Schematic



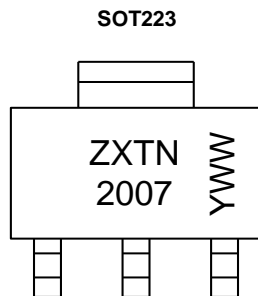
Pin-Out Top View

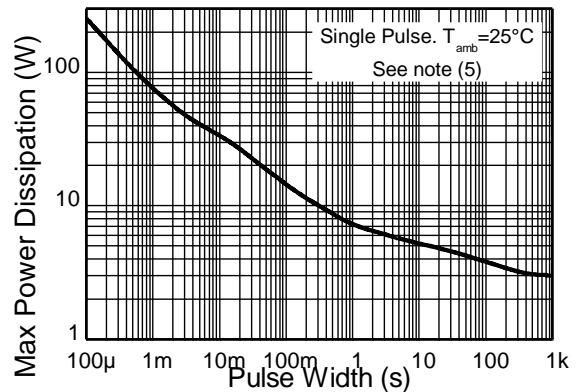
**Safe Operating Area**

**Transient Thermal Impedance**



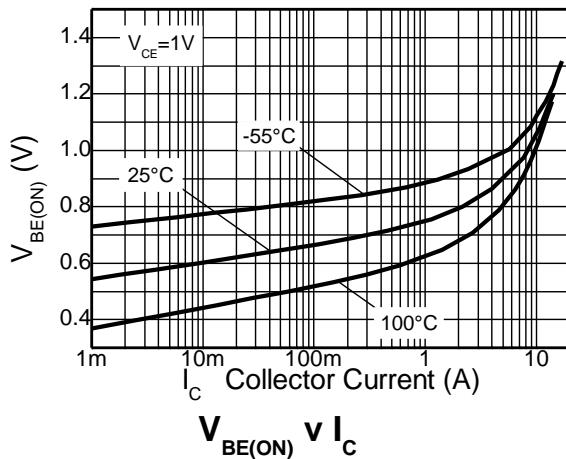
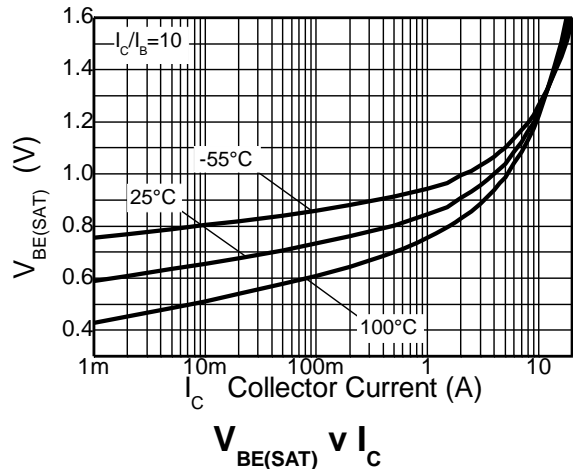
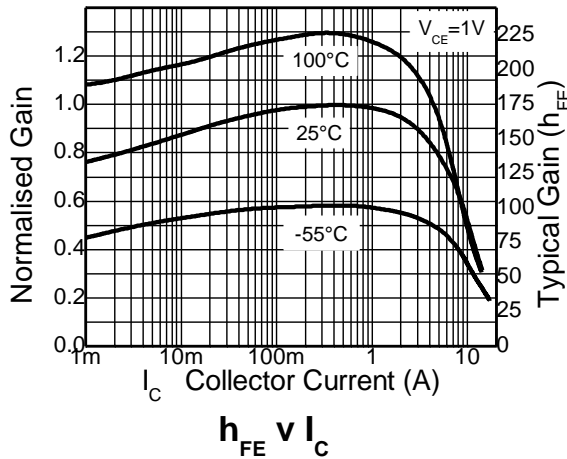
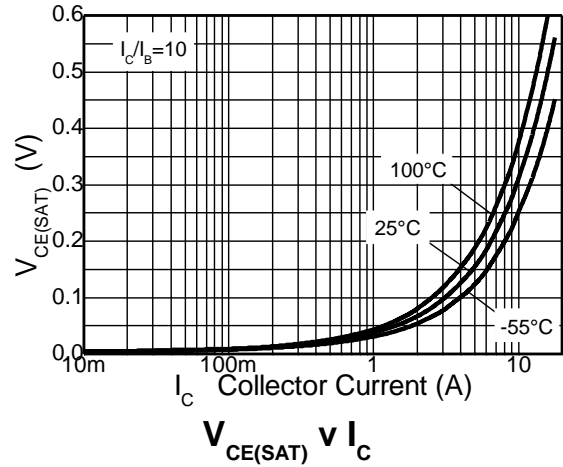
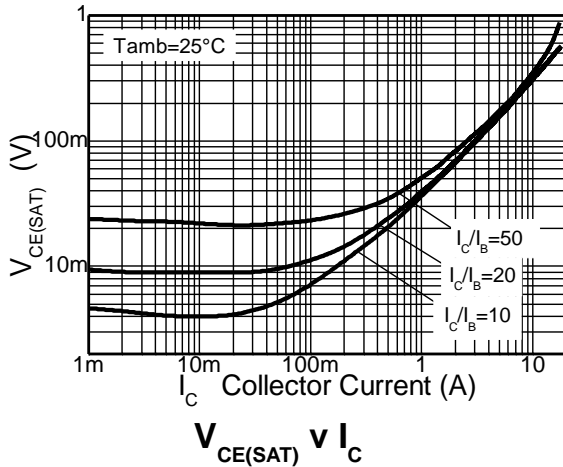
