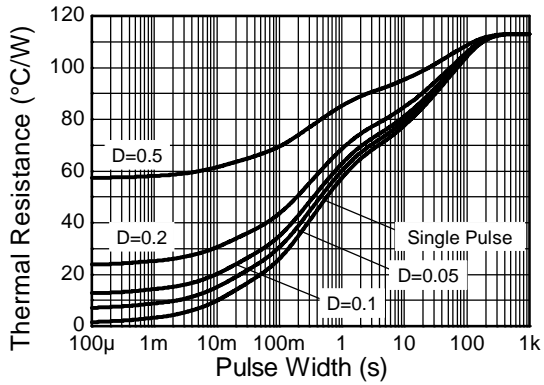

Derating Curve



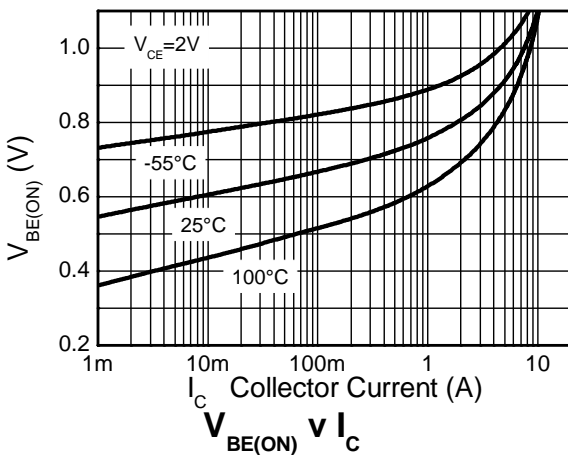
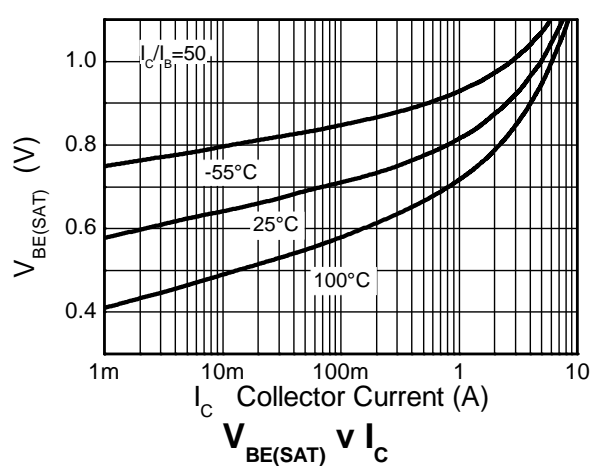
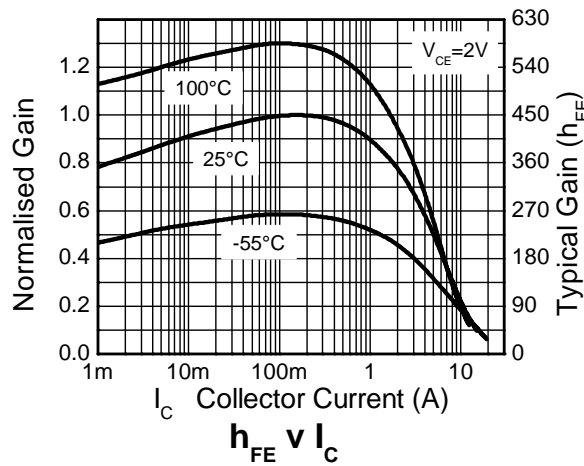
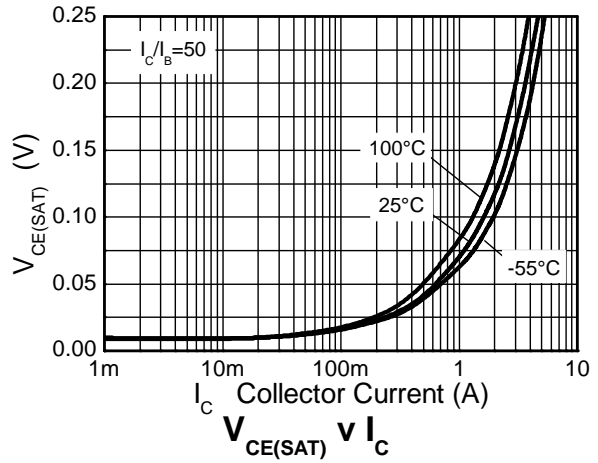
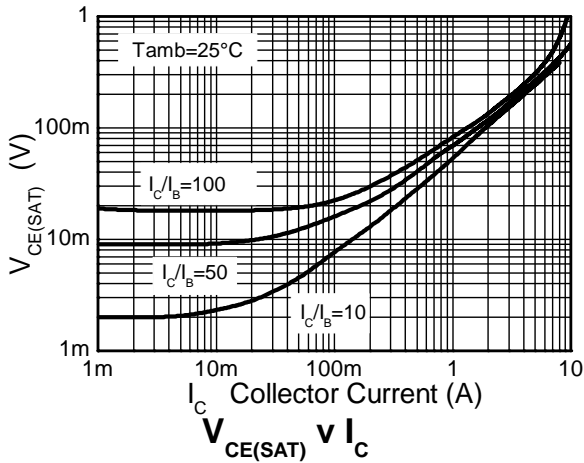

Package Outline Dimensions

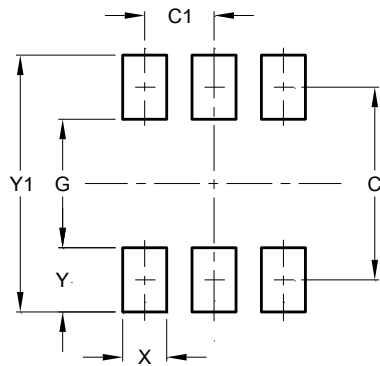
