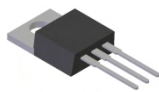

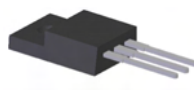

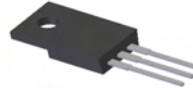
TO-220AB  
Top View



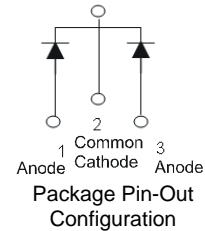
TO-220AB
