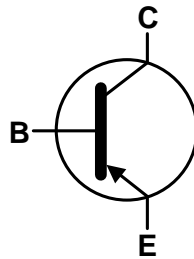

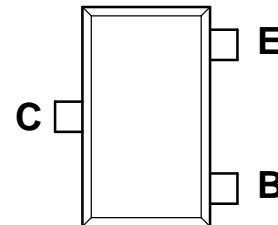

Device Symbol



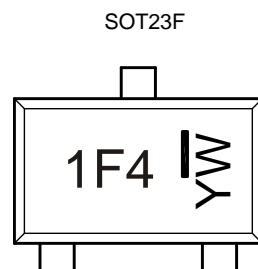
Top View

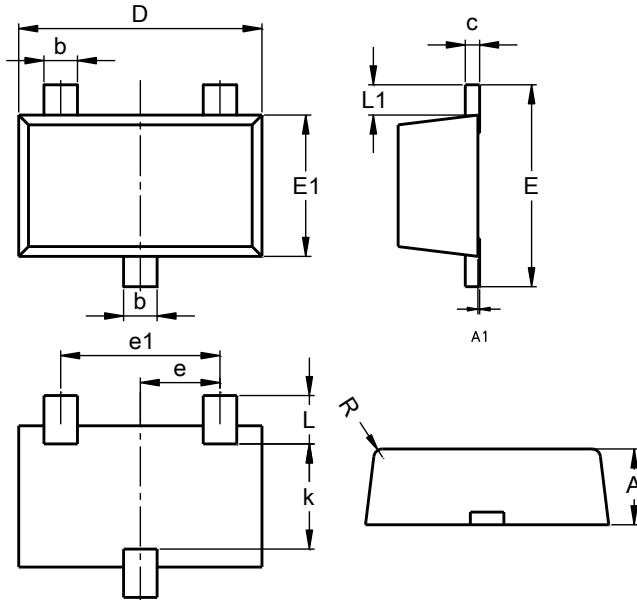
