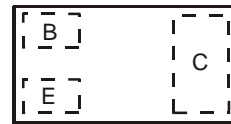

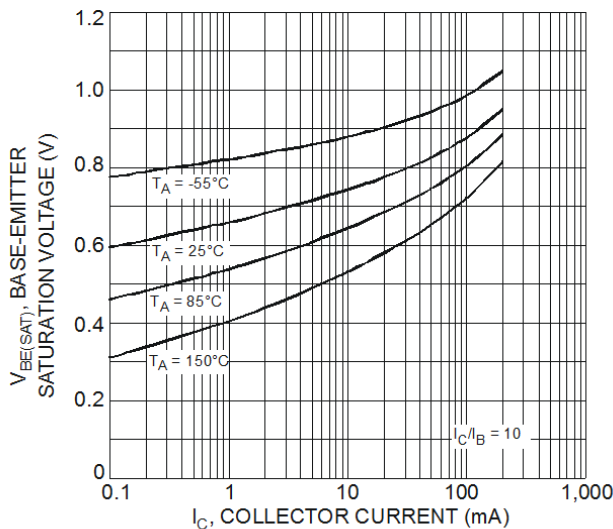
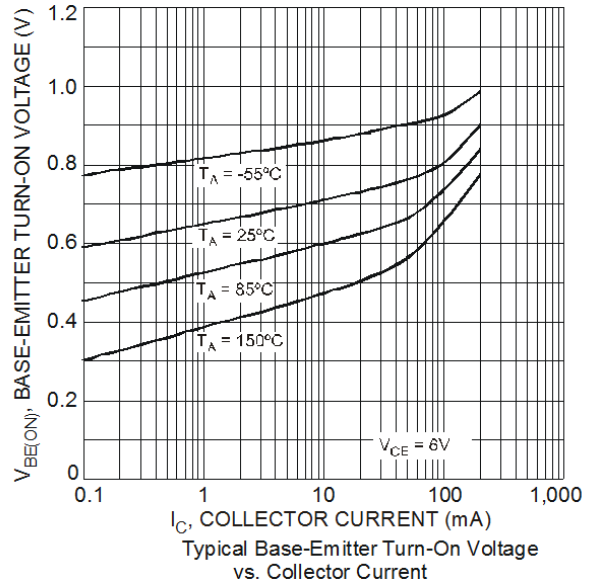
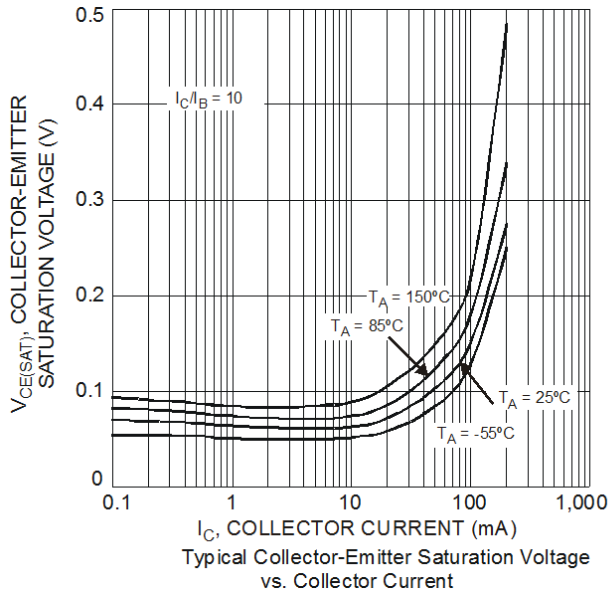
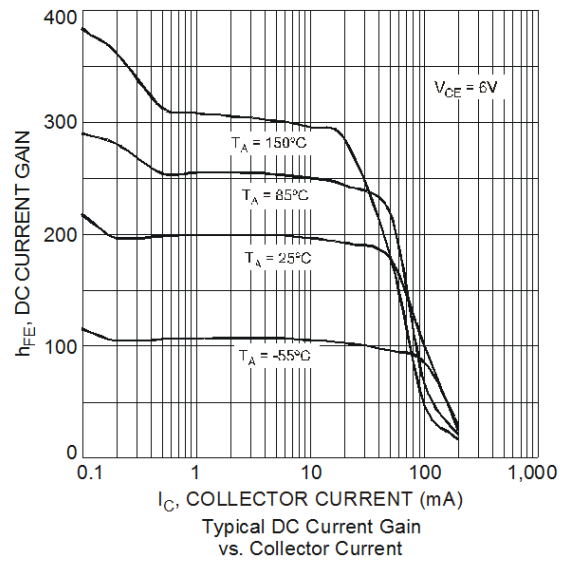
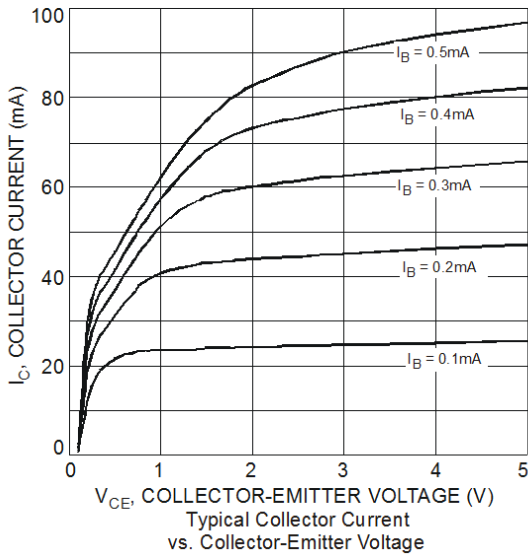
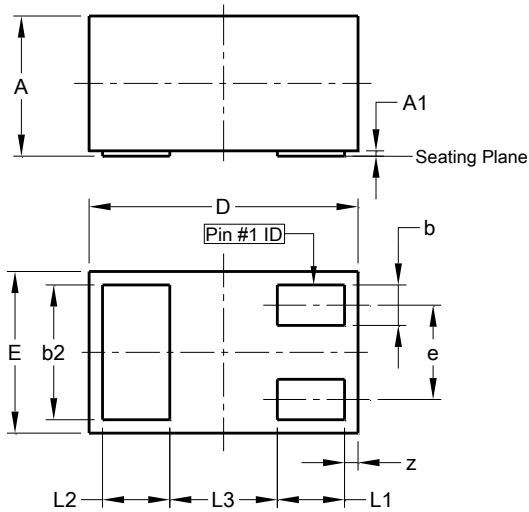


Fig. 6 Typical Base-Emitter Saturation Voltage vs. Collector Current

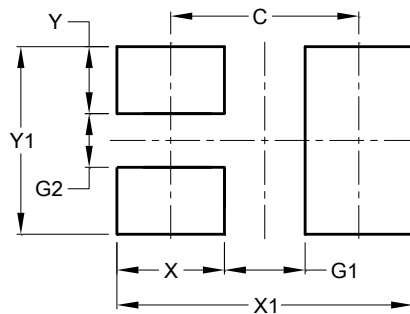
