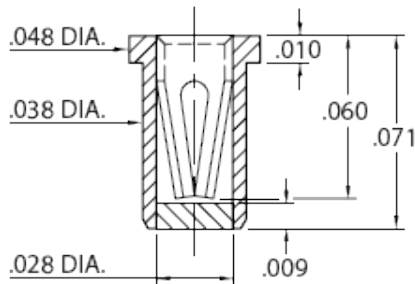

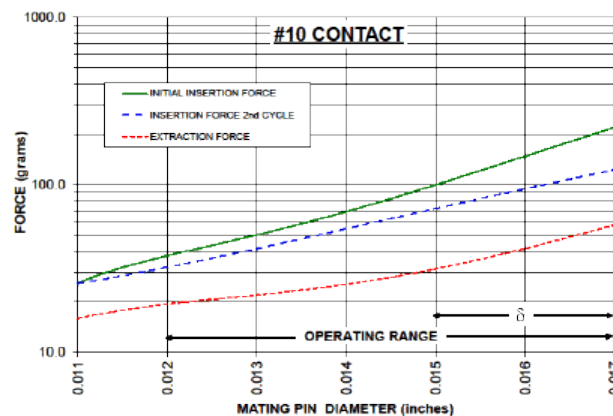

The insertion/extraction/normal force characteristics above were derived using 30 microinch gold plated contact and polished steel gauge pins having a bullet-shaped tip.

The curves represent typical average values; they are best used to compare the differences between similar size contacts and to guide you in selecting one that is suitable for your application.
