## ESD Flux Bottles

New development process of moulding polyethylene bottles utilising a concentrate that does not contain any Exthoxylated Tertiary Amine, which is widely used as an antistatic agent. These ESD safe bottles have an average surface resistivity of  $10^9$  to  $10^{10}$  Ohms/square and do not have any less desirable features associated with surfactant laden material.

These bottles will dissipate a static charge of  $\pm 5000V$  in less than two seconds at 40% relative humidity. By their chemical nature, they will not have any chemical reactivity with solvents as TCE or alcohol.
