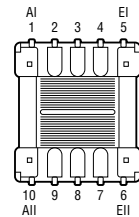

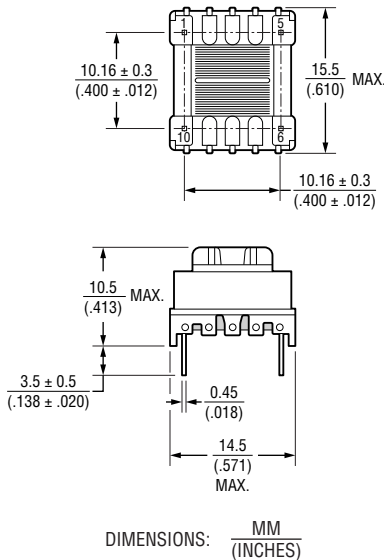

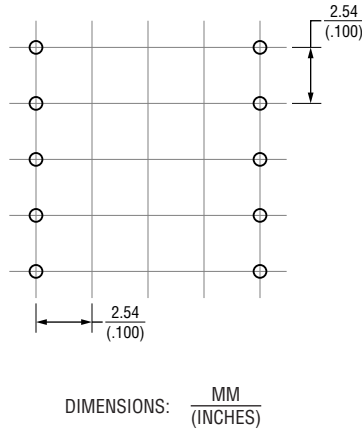
Schematic



Product Dimensions



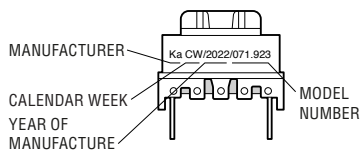
Recommended PCB Layout

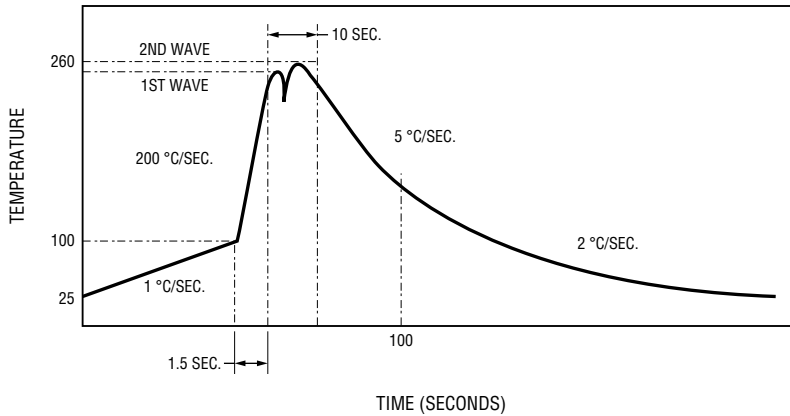
