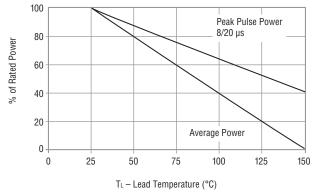

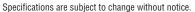






## **Pulse Waveform**

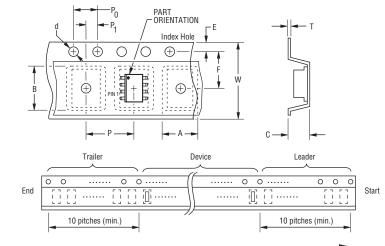

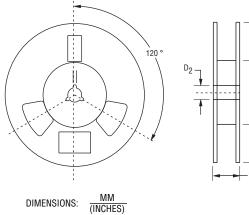

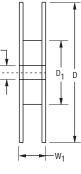
