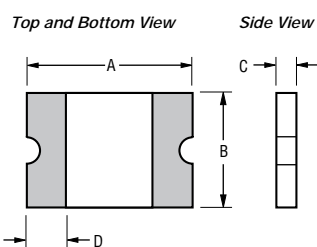

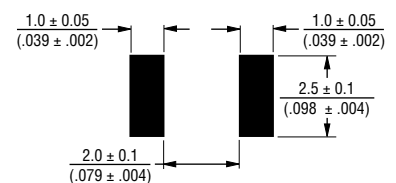

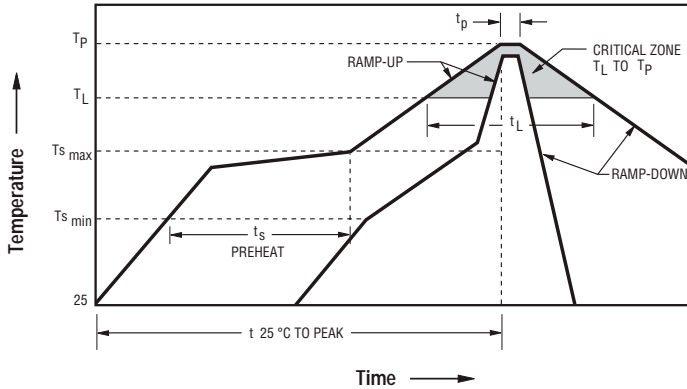

Solder Reflow Recommendations



Notes:

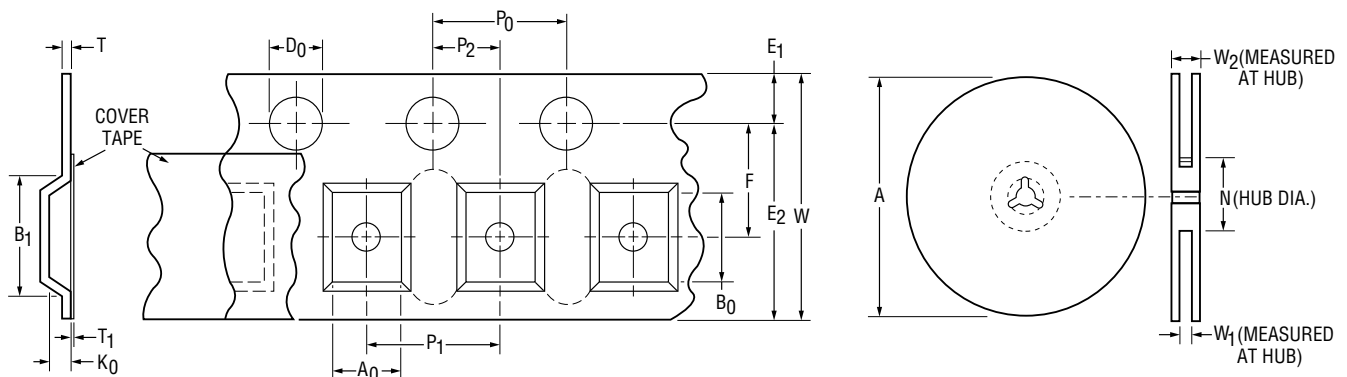
Typical Time to Trip at 23 °C
