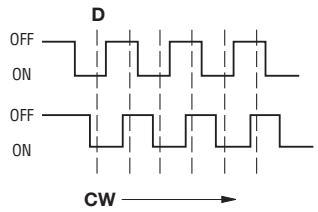

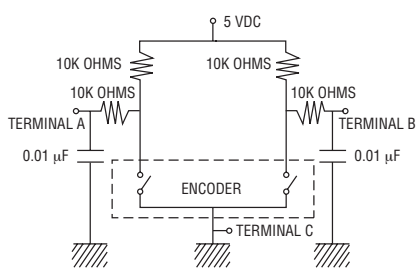

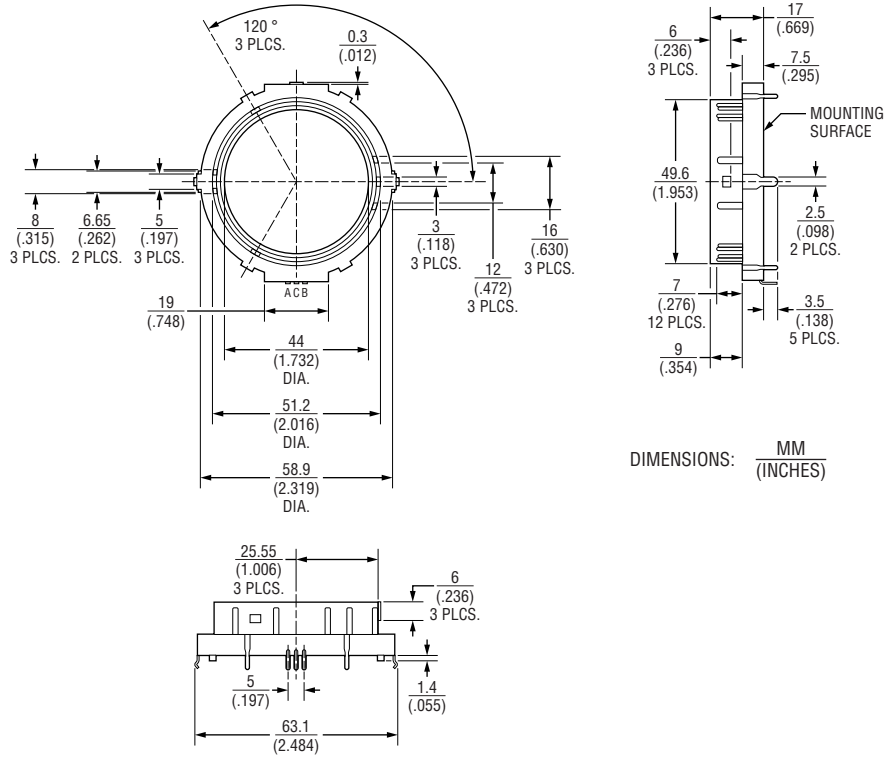
### Quadrature Output Table



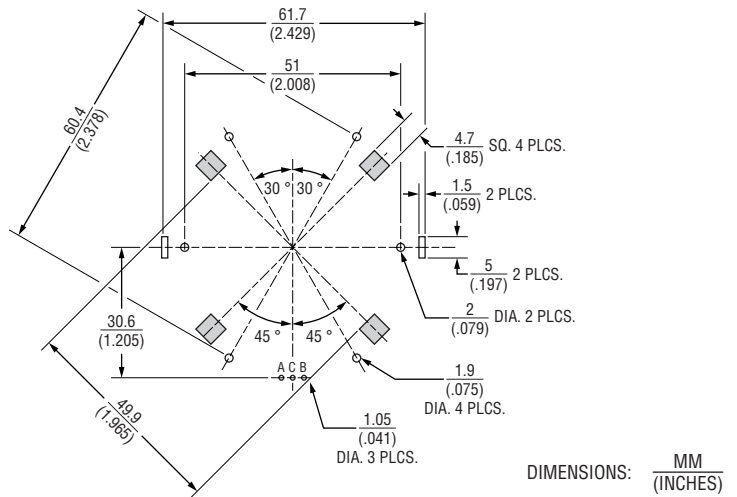
### Suggested Filter Circuit
