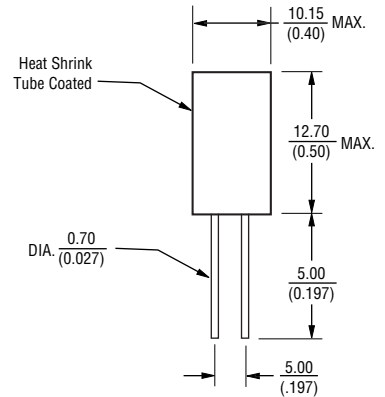

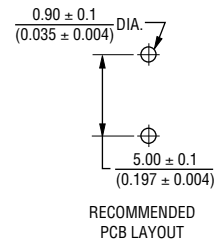

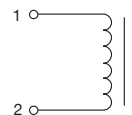


Recommended PCB Layout
