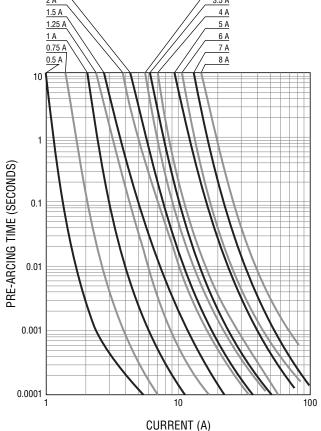

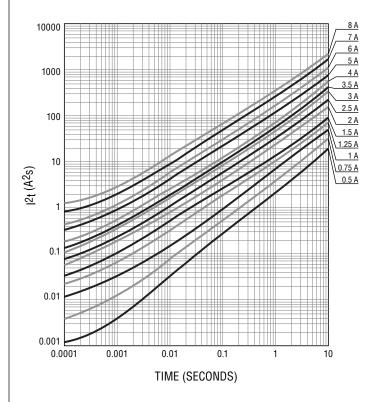

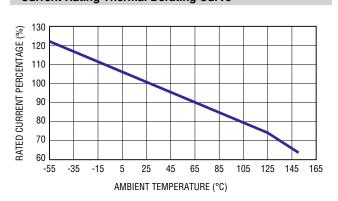

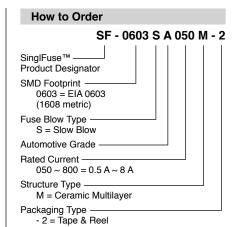

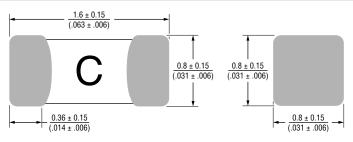

Recommended Pad Layout



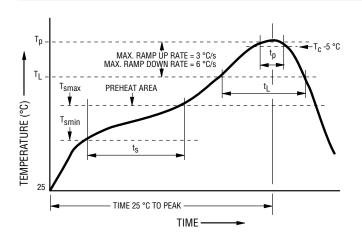
