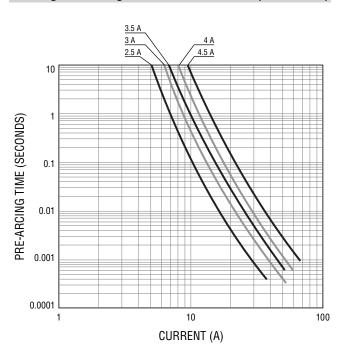

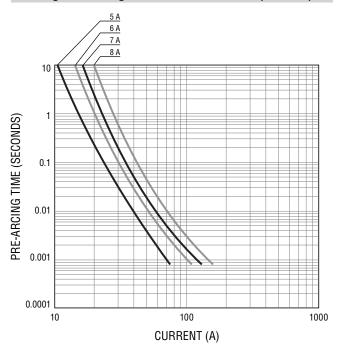

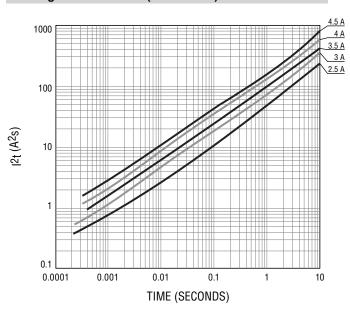
### Average Pre-Arcing Time vs. Current Curves (2.5 A - 4.5 A)



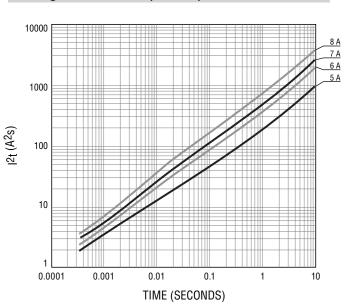
### Average Pre-Arcing Time vs. Current Curves (5 A - 8 A)

### Average I2t vs. t Curves (5 A - 8 A)



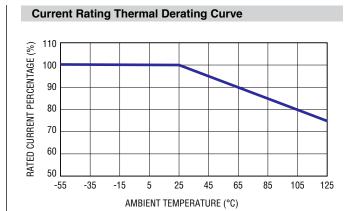

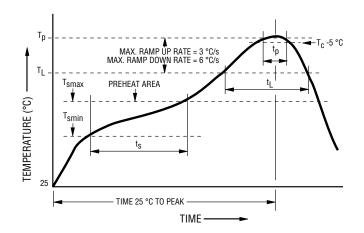
