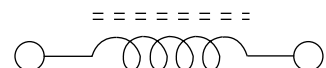

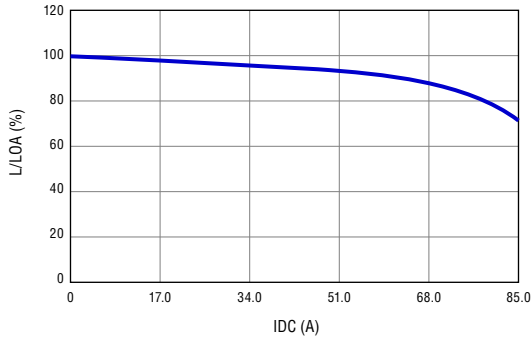


Electrical Schematic

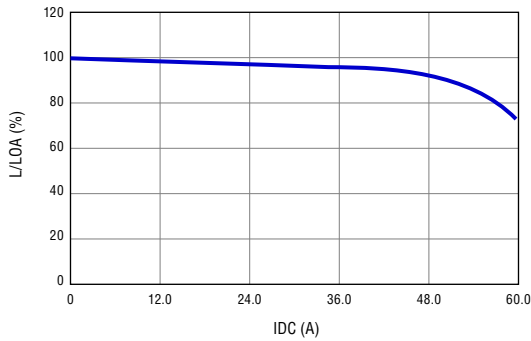


Typical Percentage of Inductance vs. Current Curves

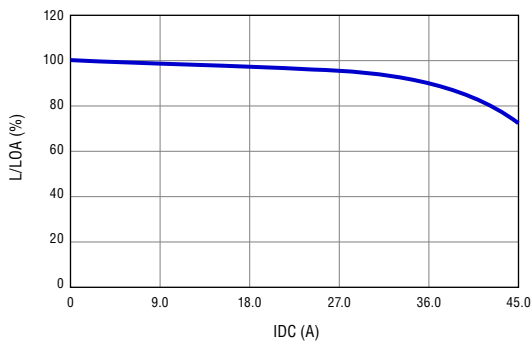

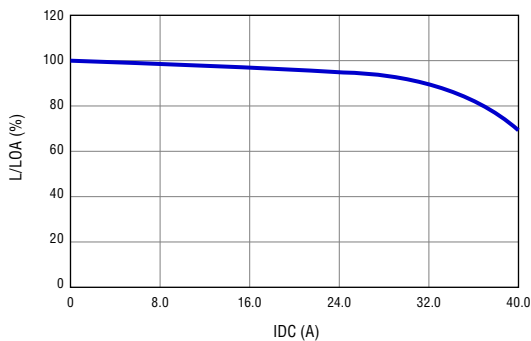

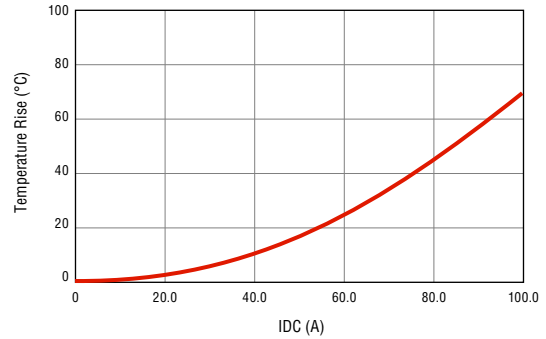

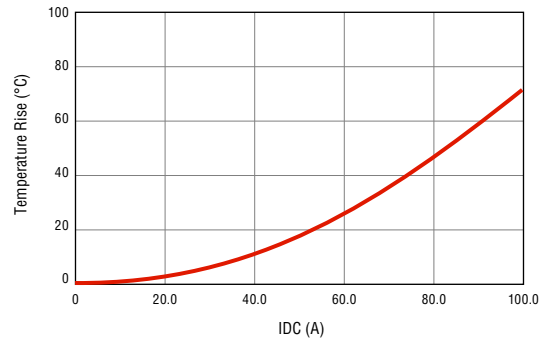


Temperature Rise vs. Current Plots

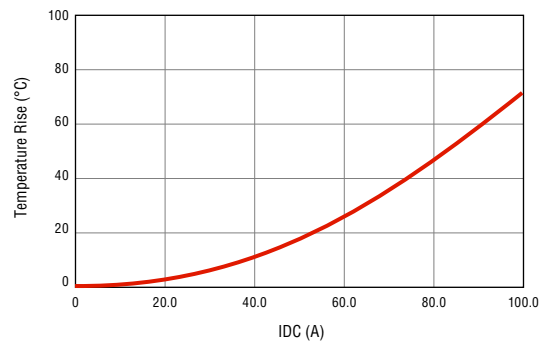

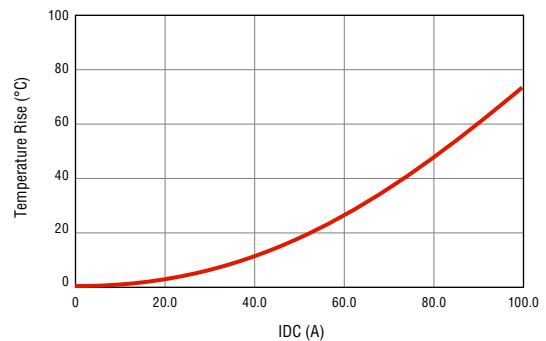

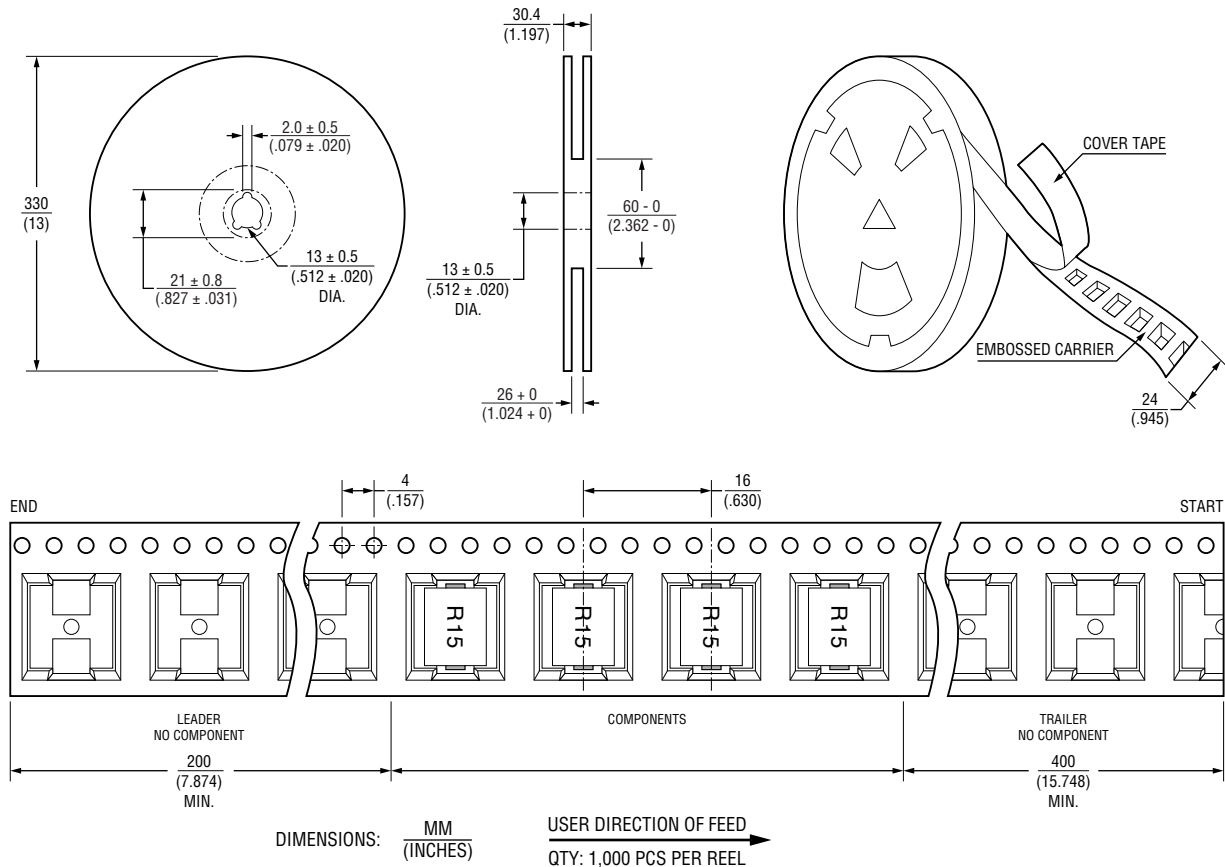
