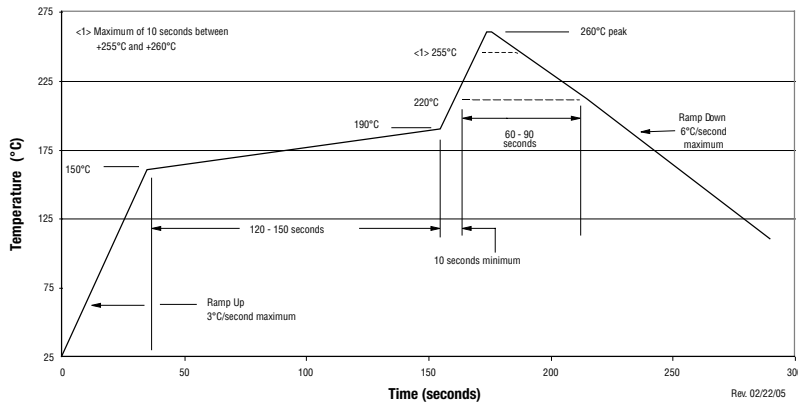

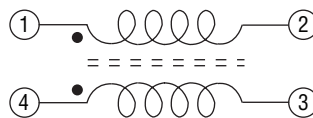

Schematic



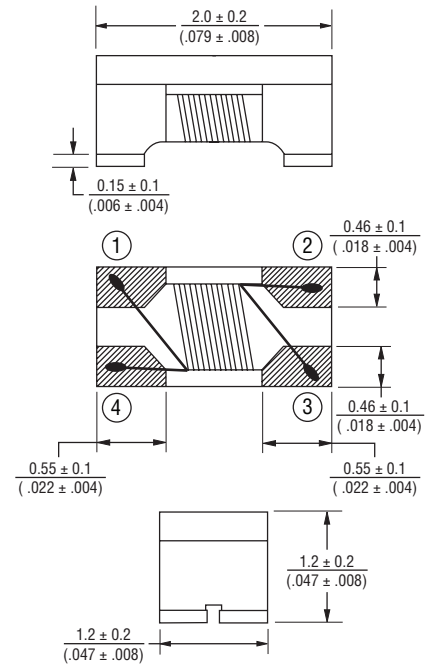
