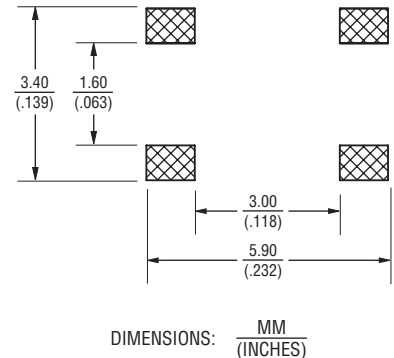

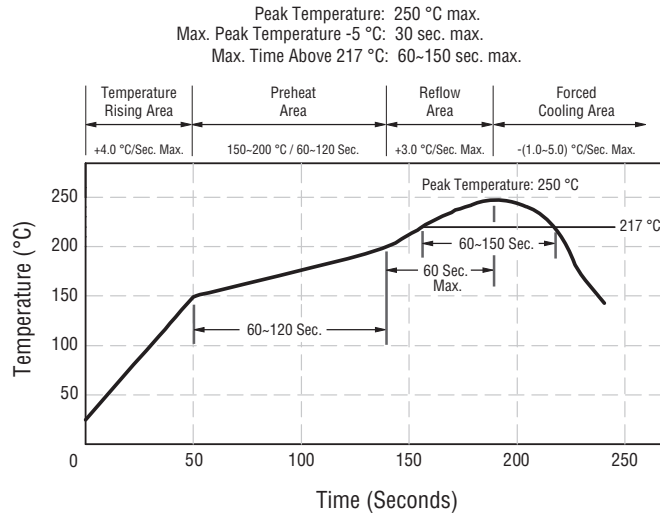

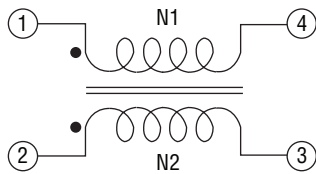

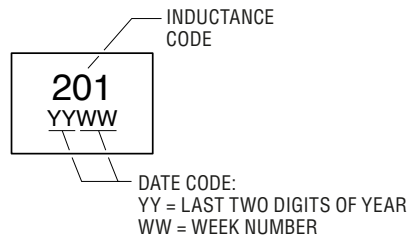
Soldering Profile



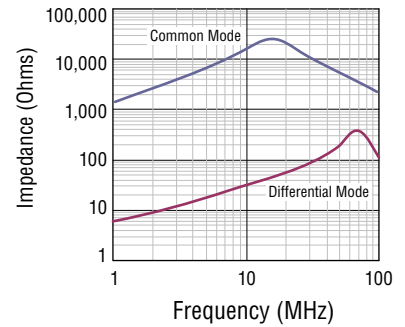
Schematic



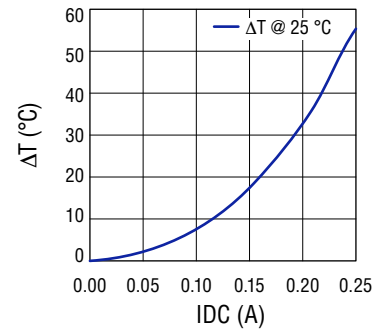
Typical Part Marking

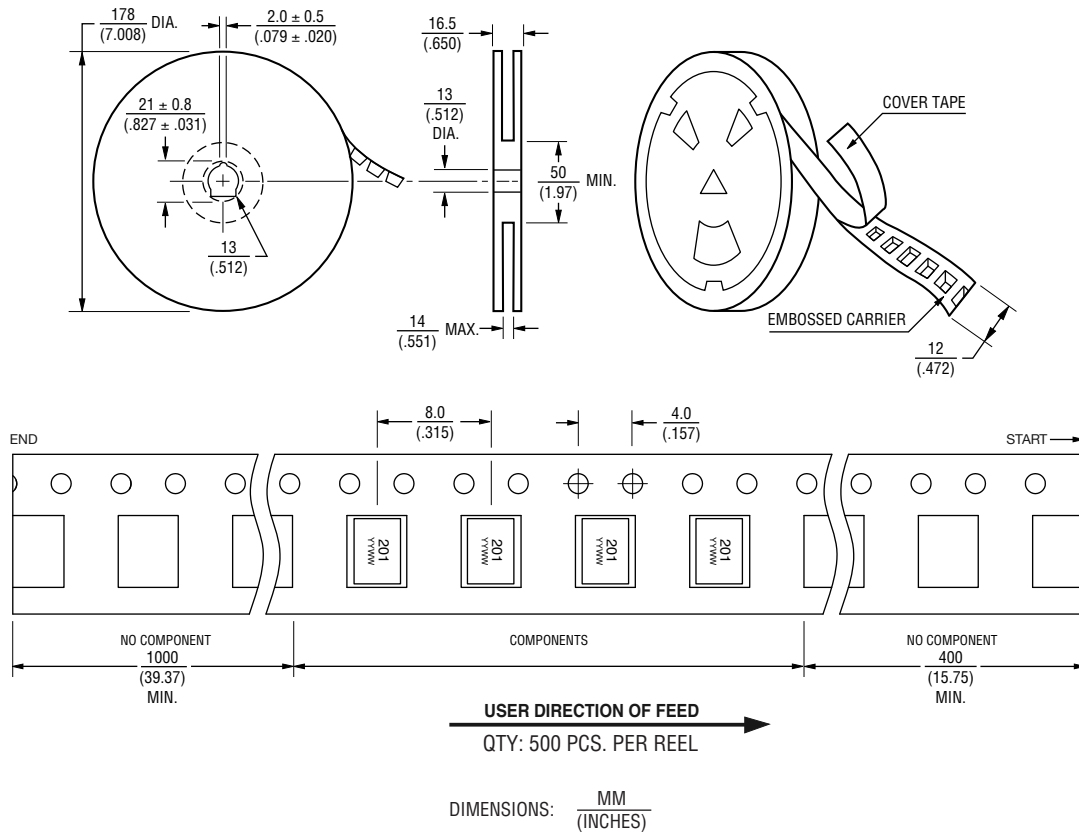
