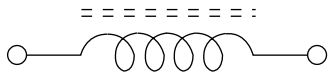

## Electrical Schematic

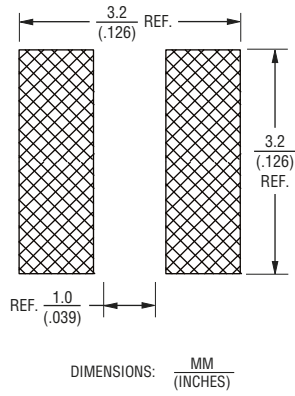
