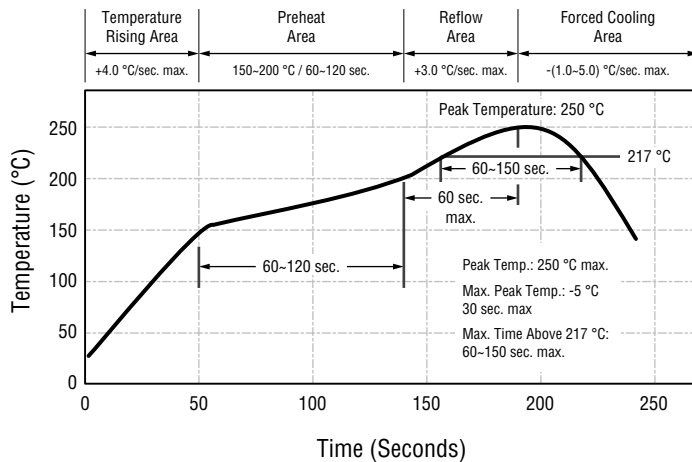

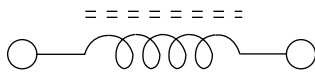

Electrical Schematic

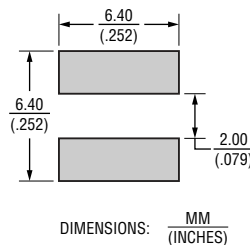
