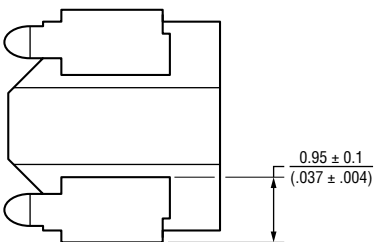

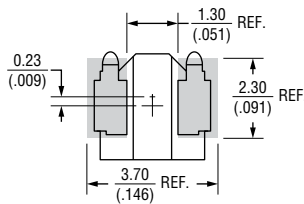

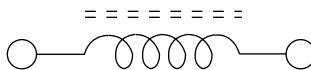


Recommended Layout
