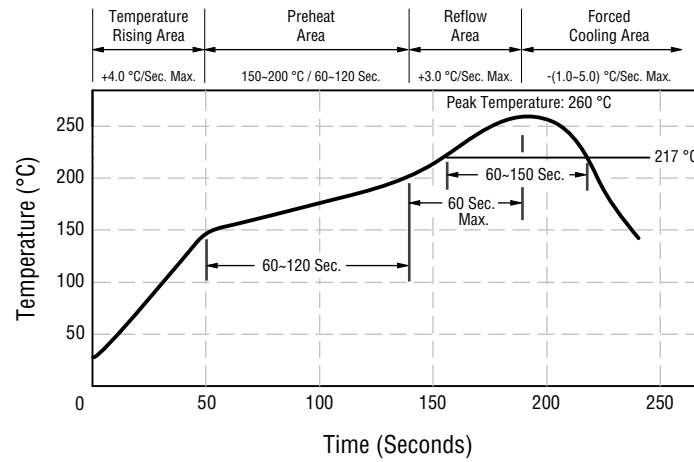


## L vs. I Charts



Soldering Profile

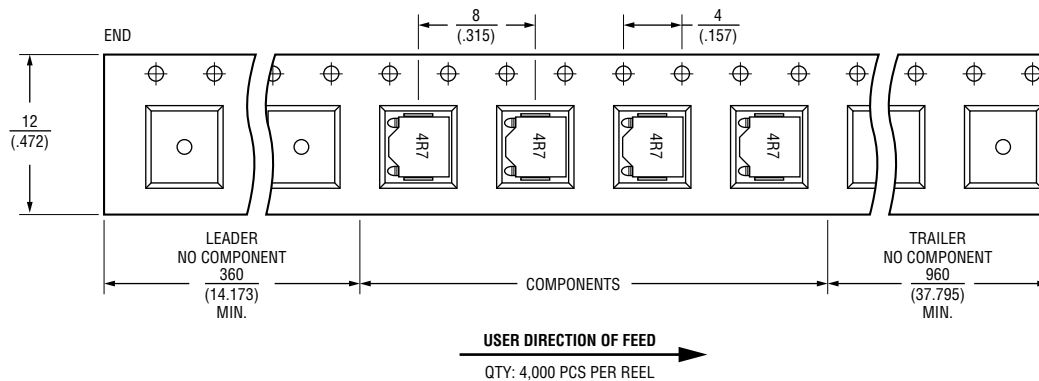
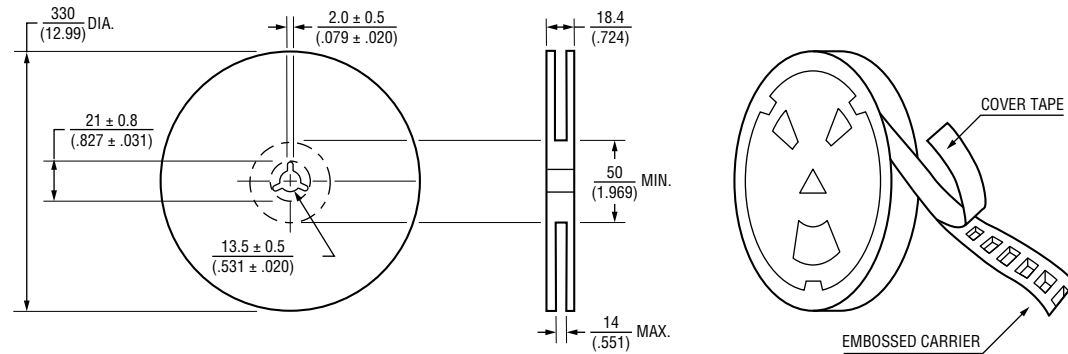
