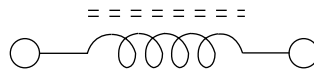

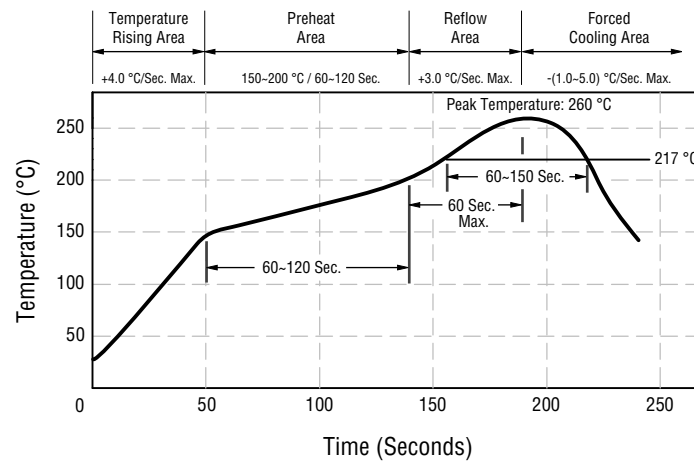

Soldering Profile

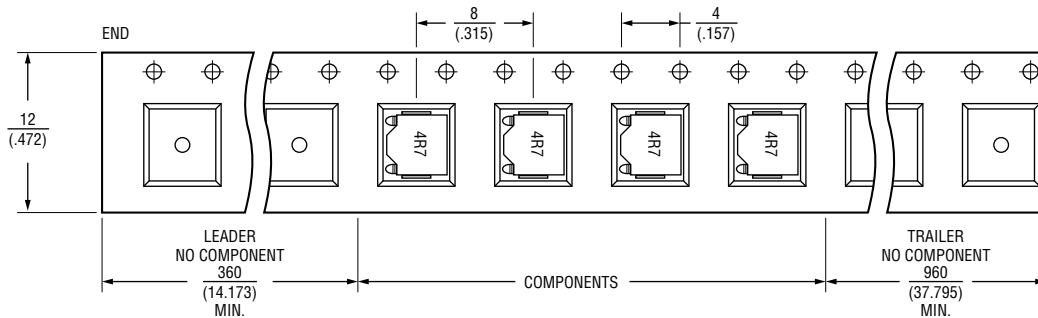
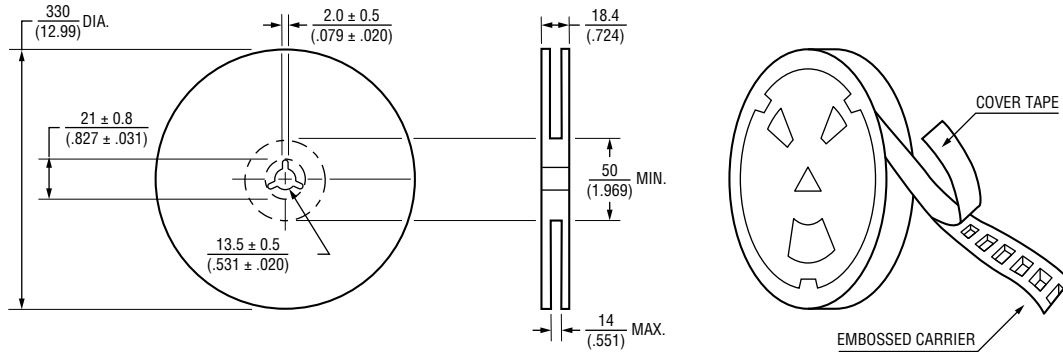
