Soldering Profile

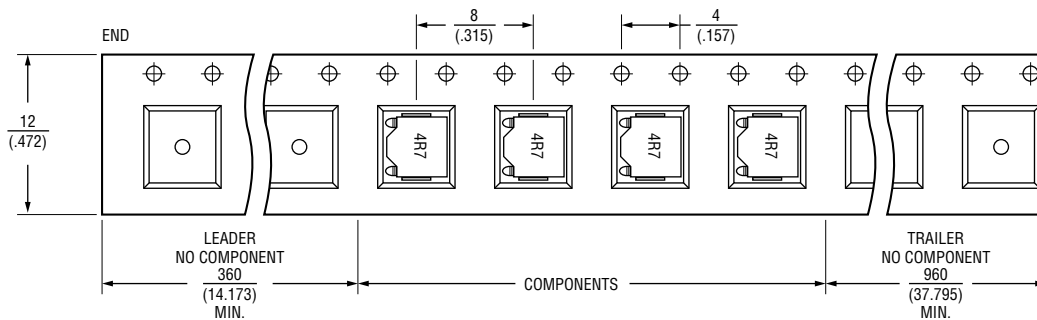
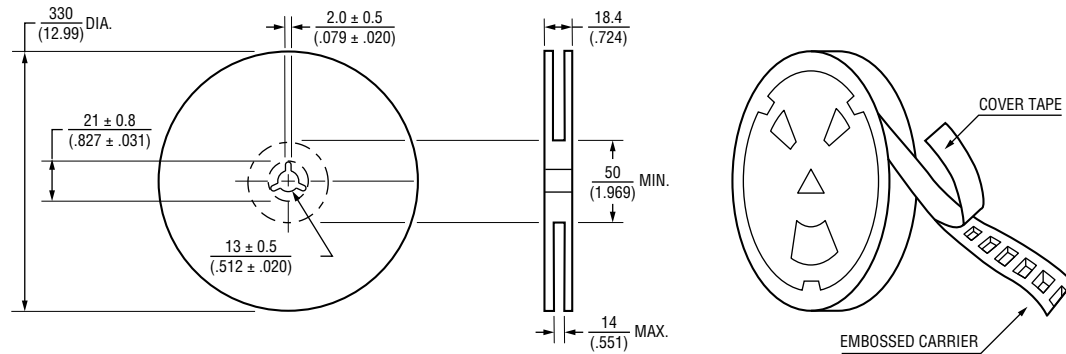
