Soldering Profile

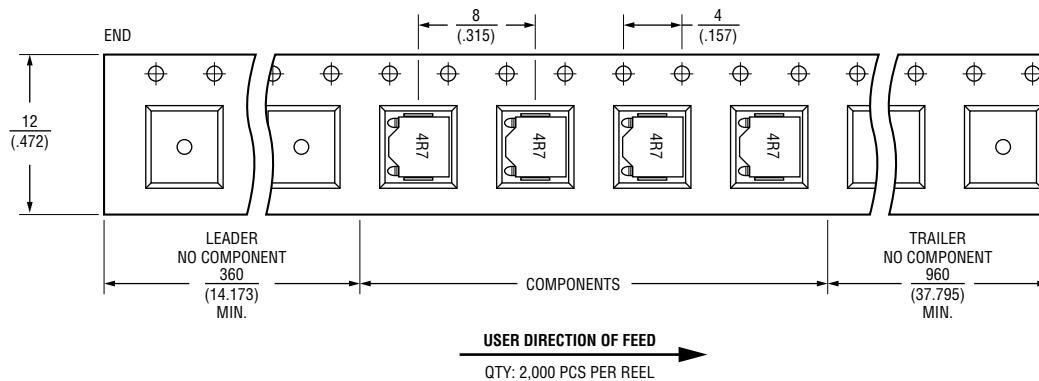
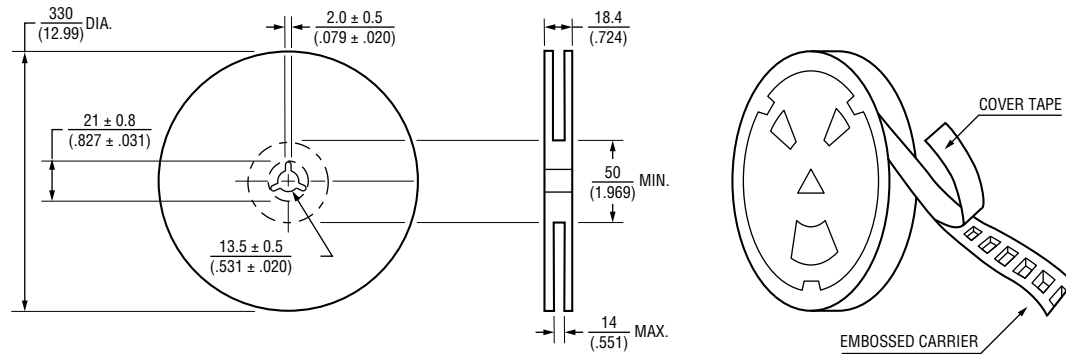
