Soldering Profile

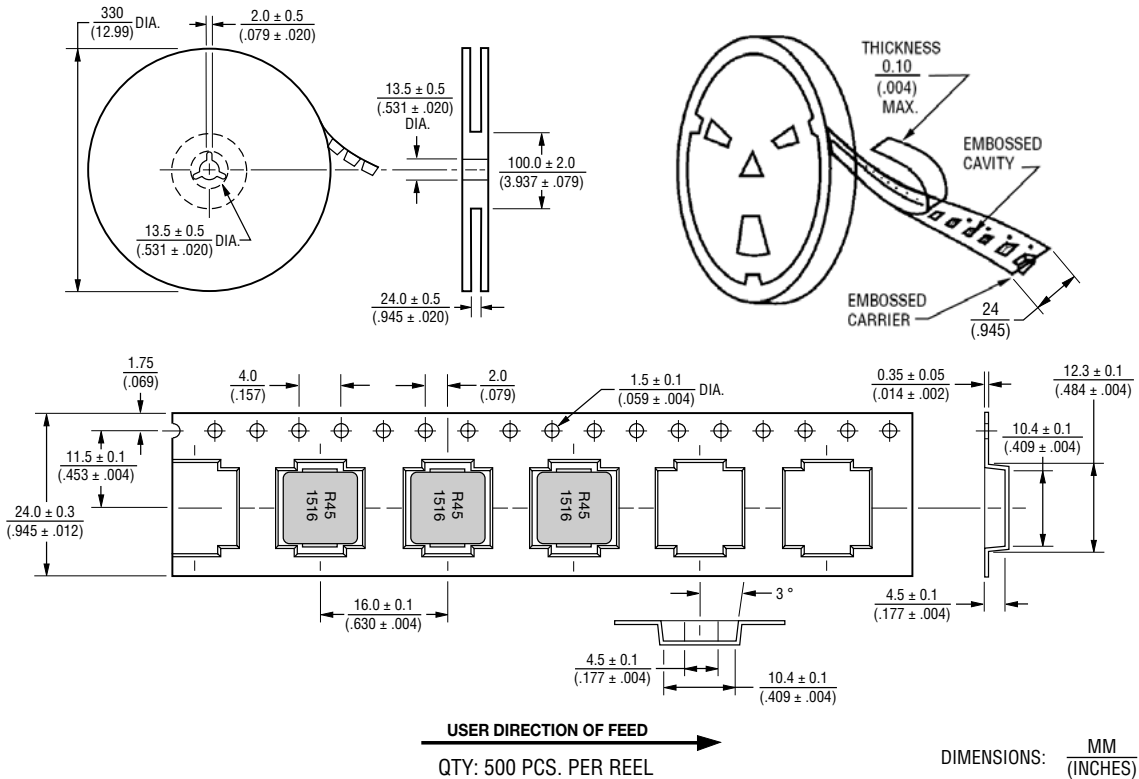
