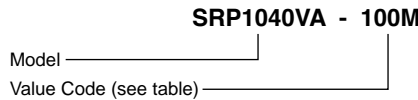
Recommended Layout



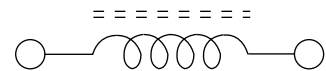
Typical Part Marking

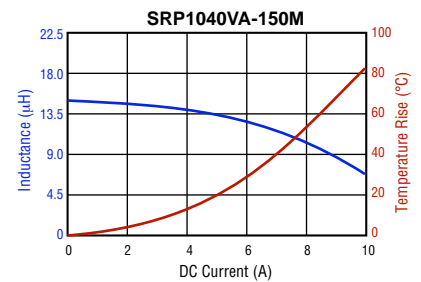
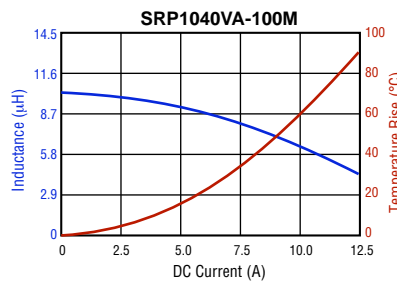
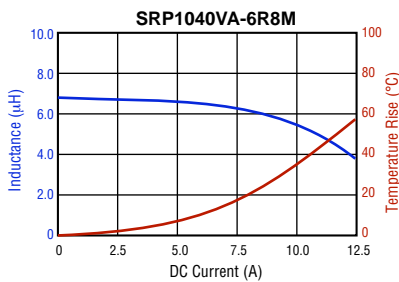
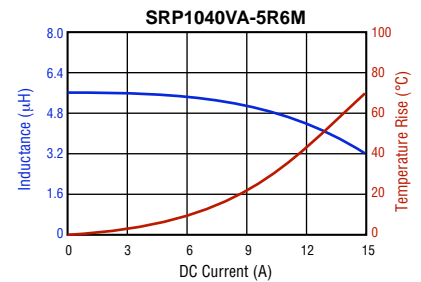
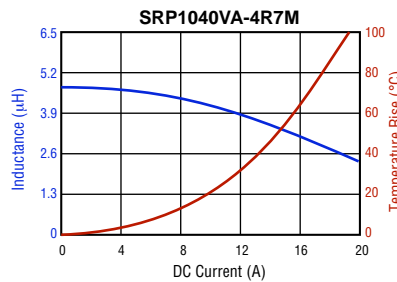
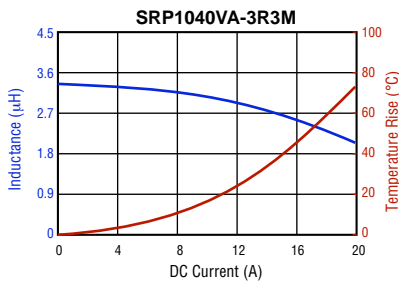
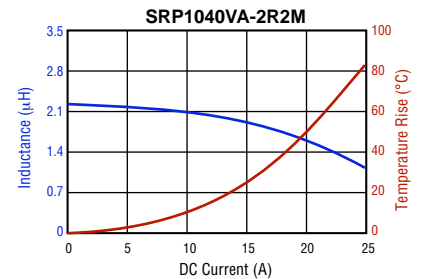
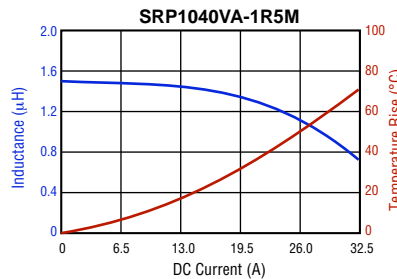
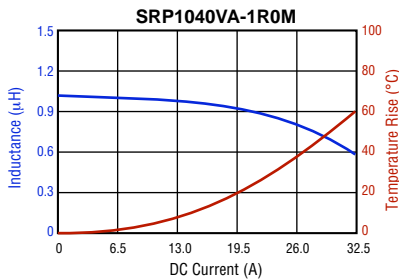
Soldering Profile
