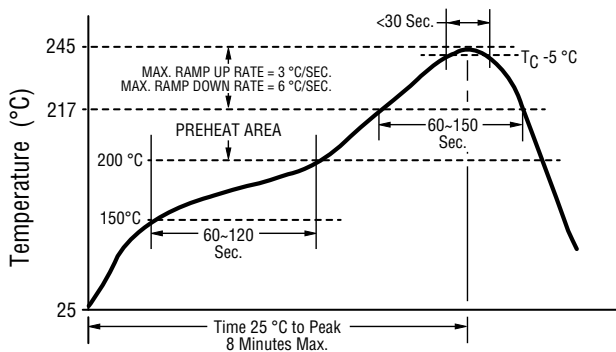

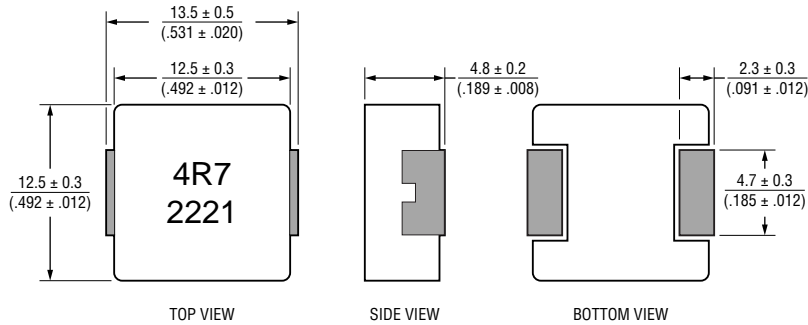

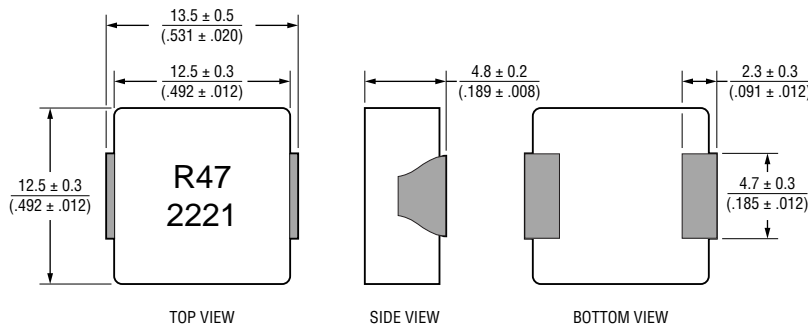

Lead Frame Terminal

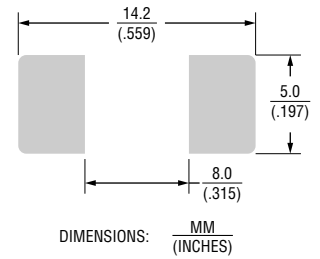


Non-Lead Frame Terminal

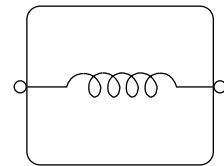

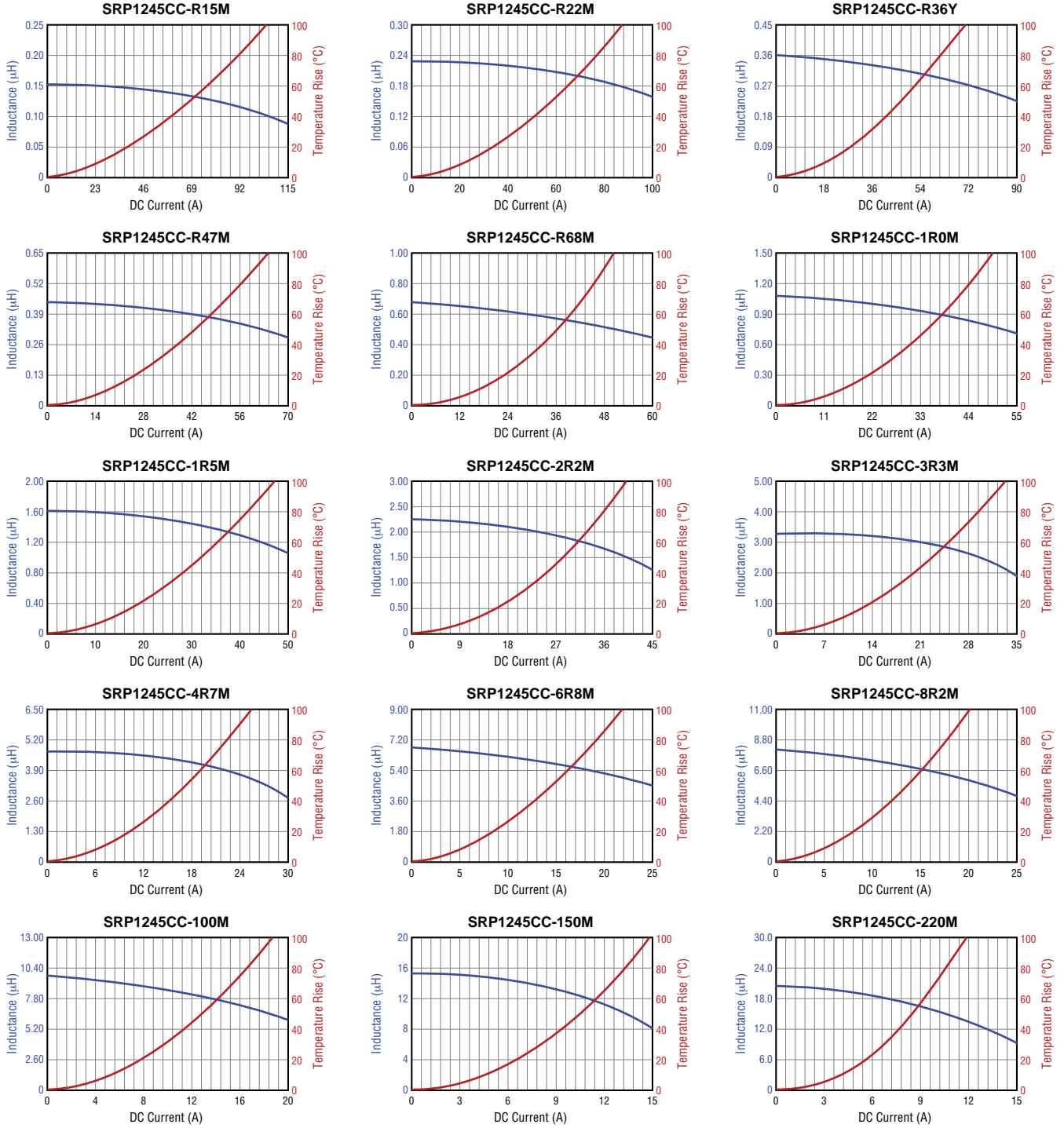

L vs. IDC and Temperature vs. IDC Curves

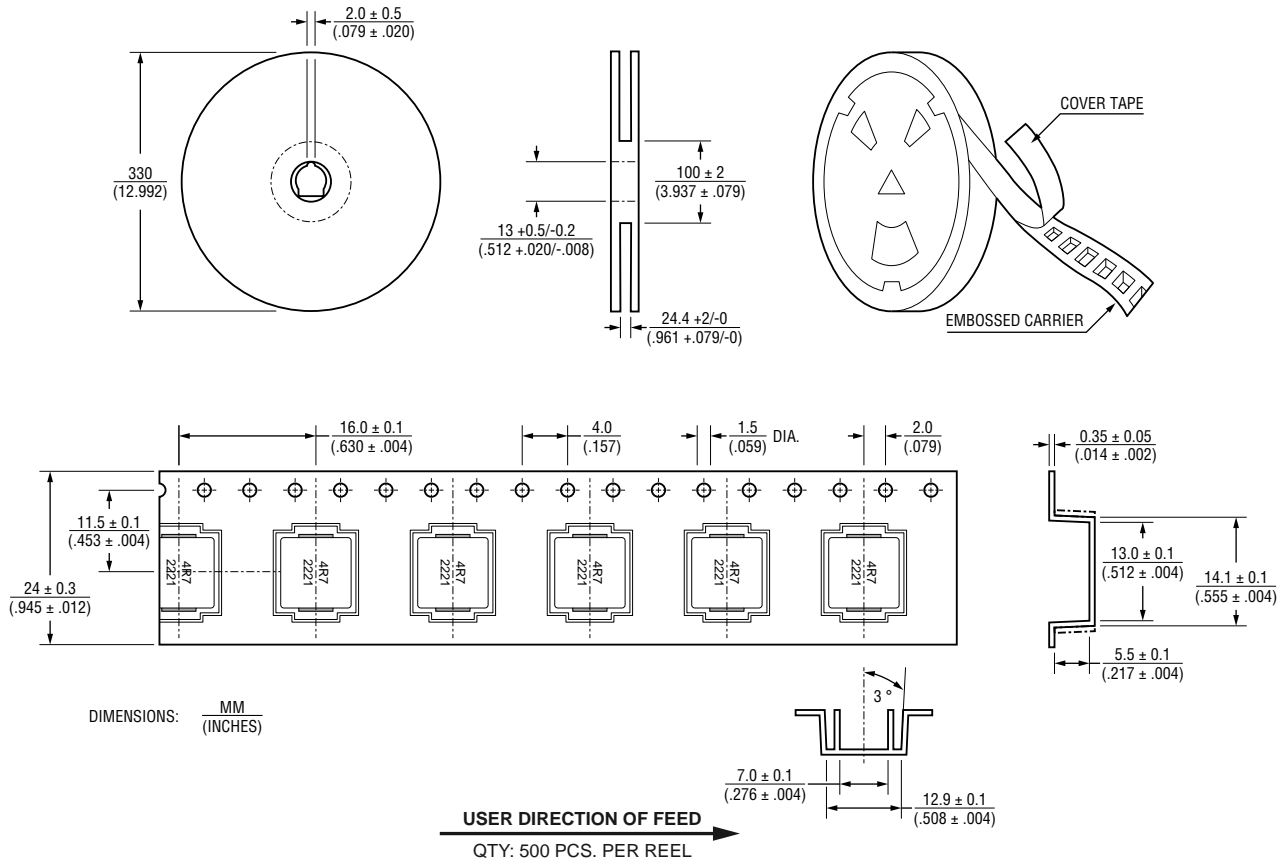
