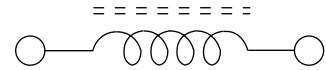
L vs. I Charts



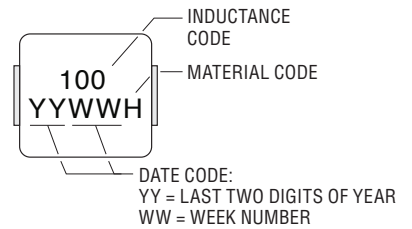
Soldering Profile



Electrical Schematic



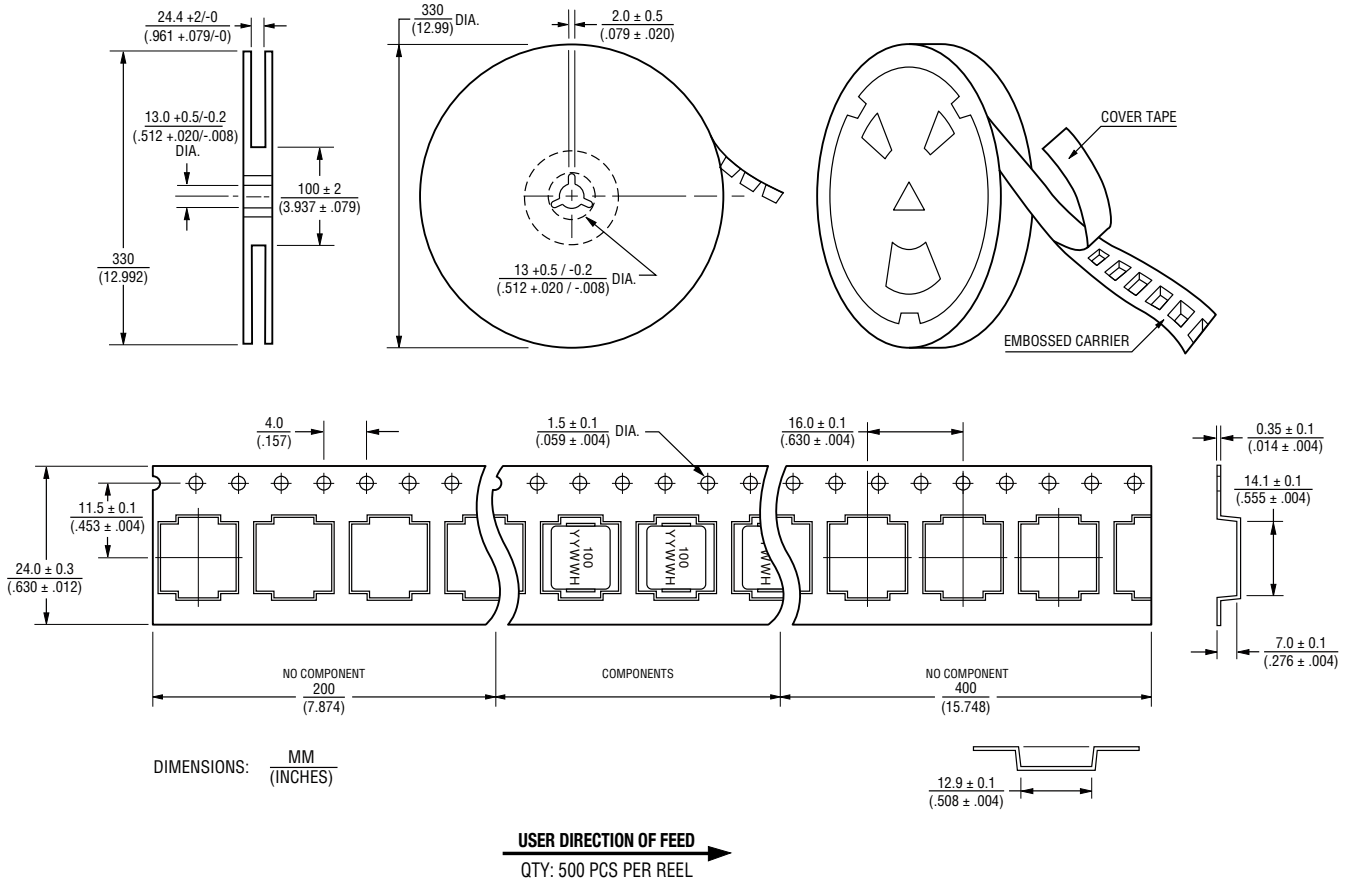
Typical Part Marking
