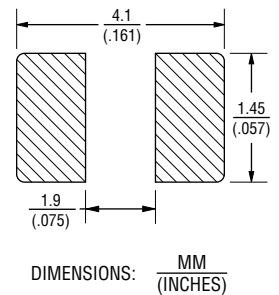

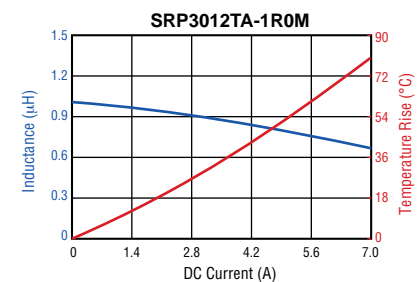
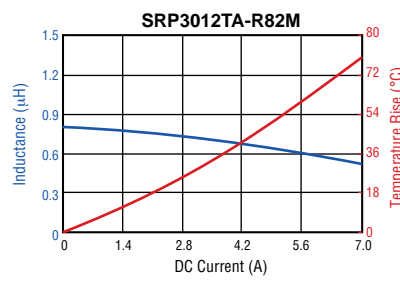
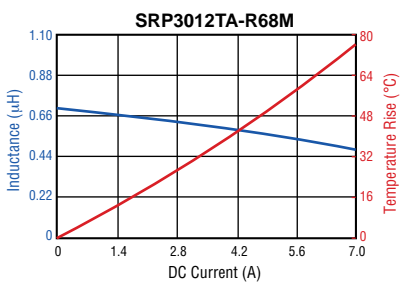
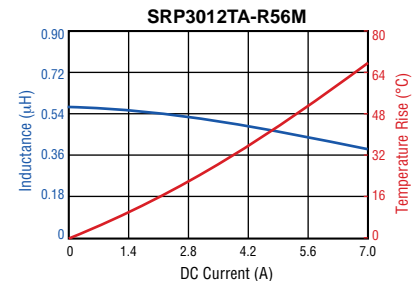
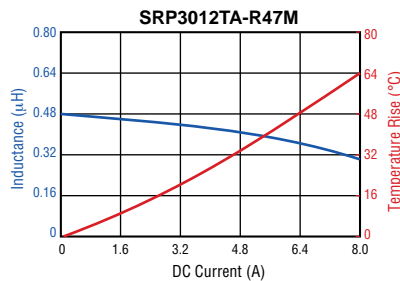
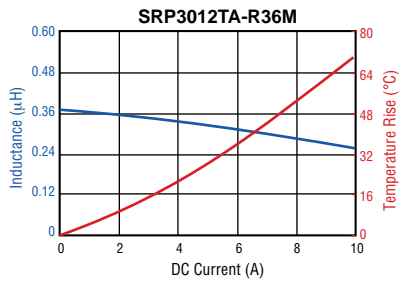
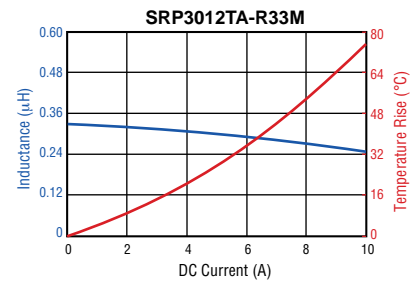
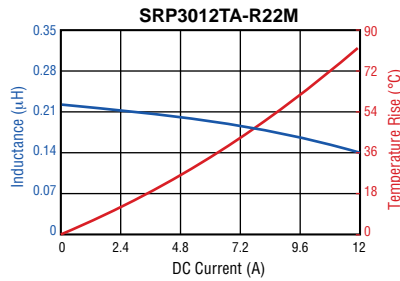
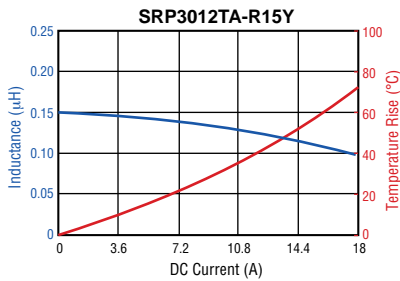


Soldering Profile
