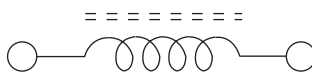

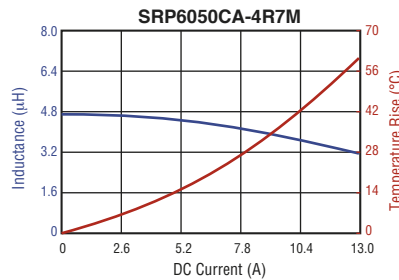
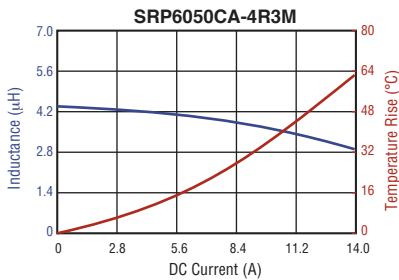
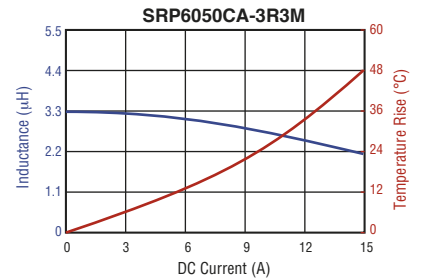
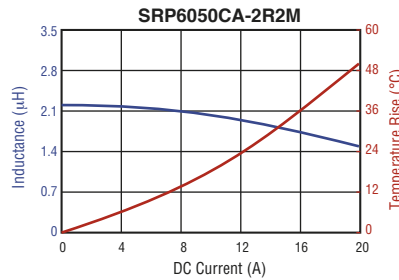
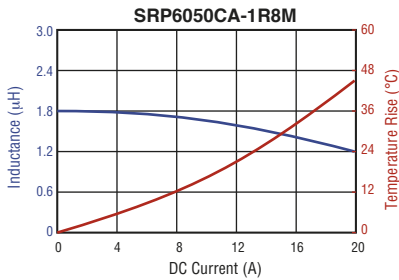
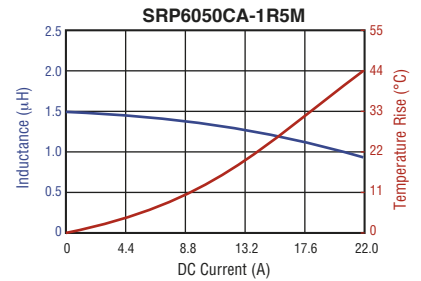
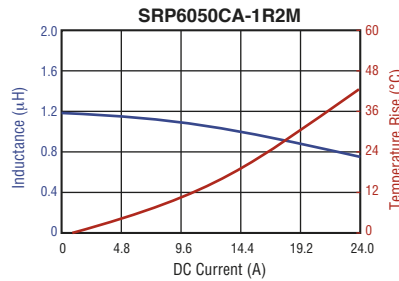
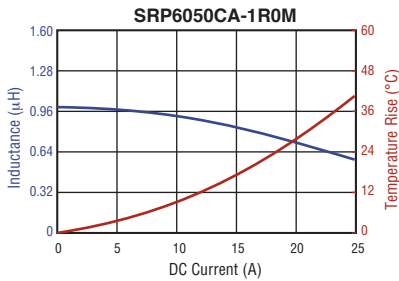
Soldering Profile

L vs. I Charts

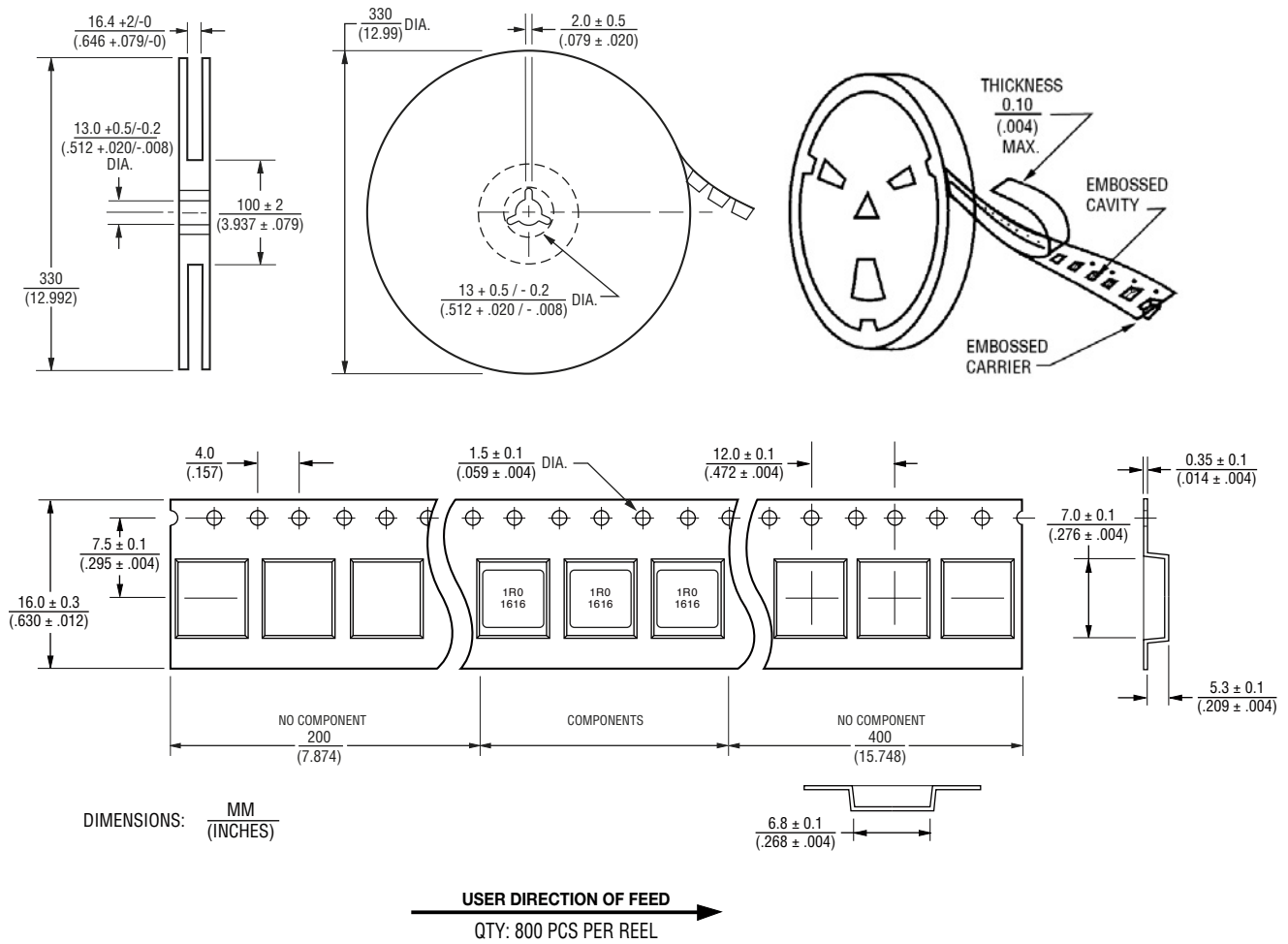
