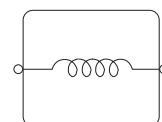

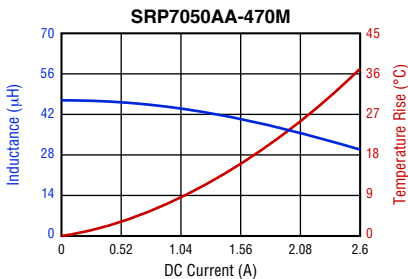
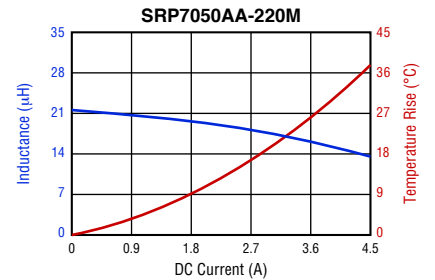
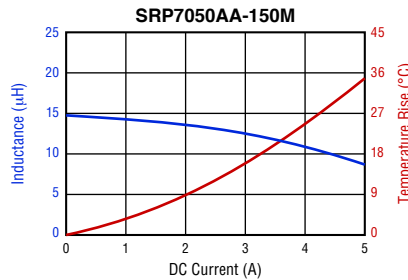
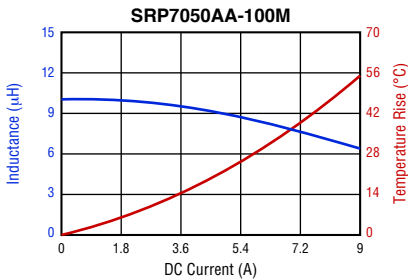
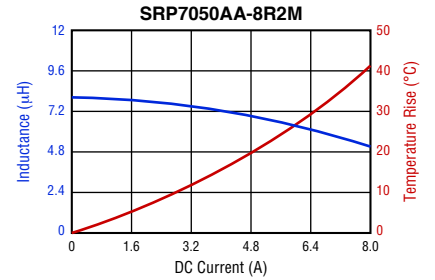
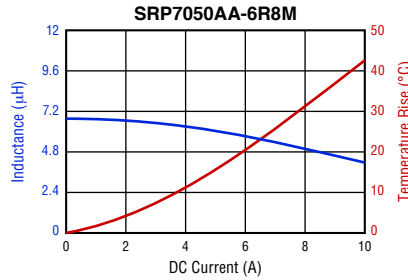
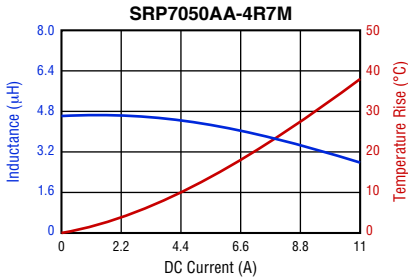
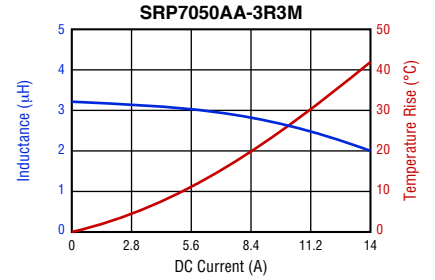
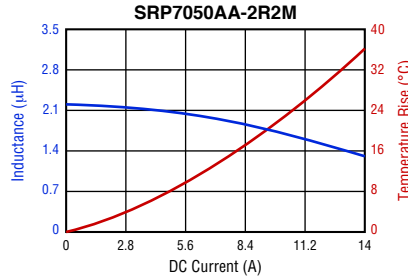
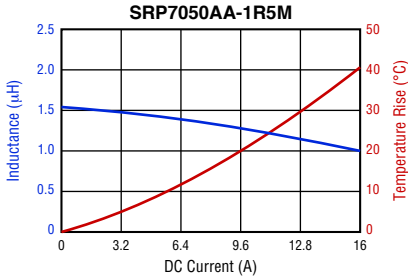
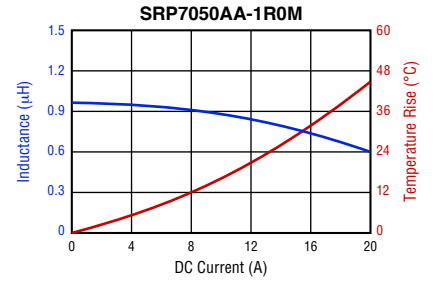
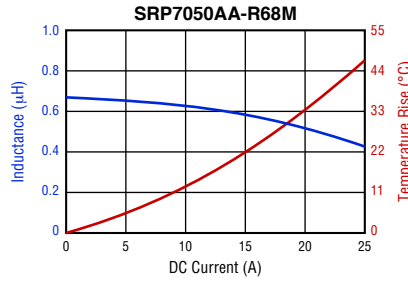
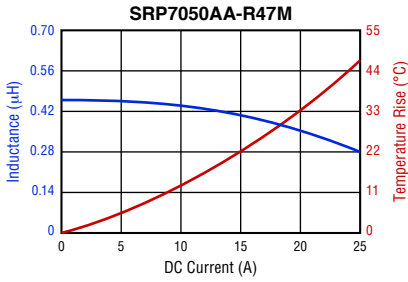
Electrical Schematic

L vs. I Charts

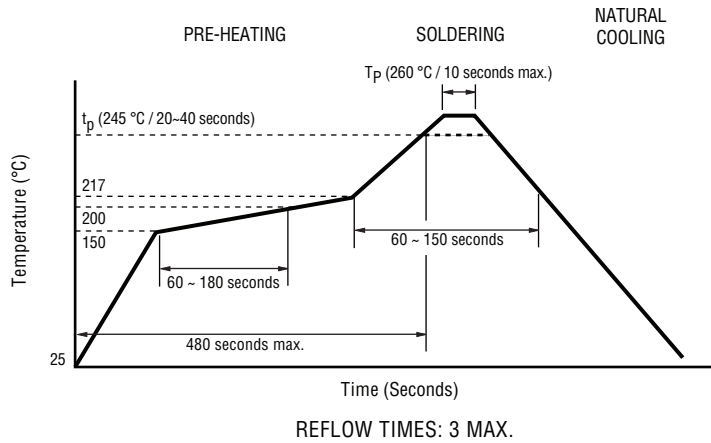

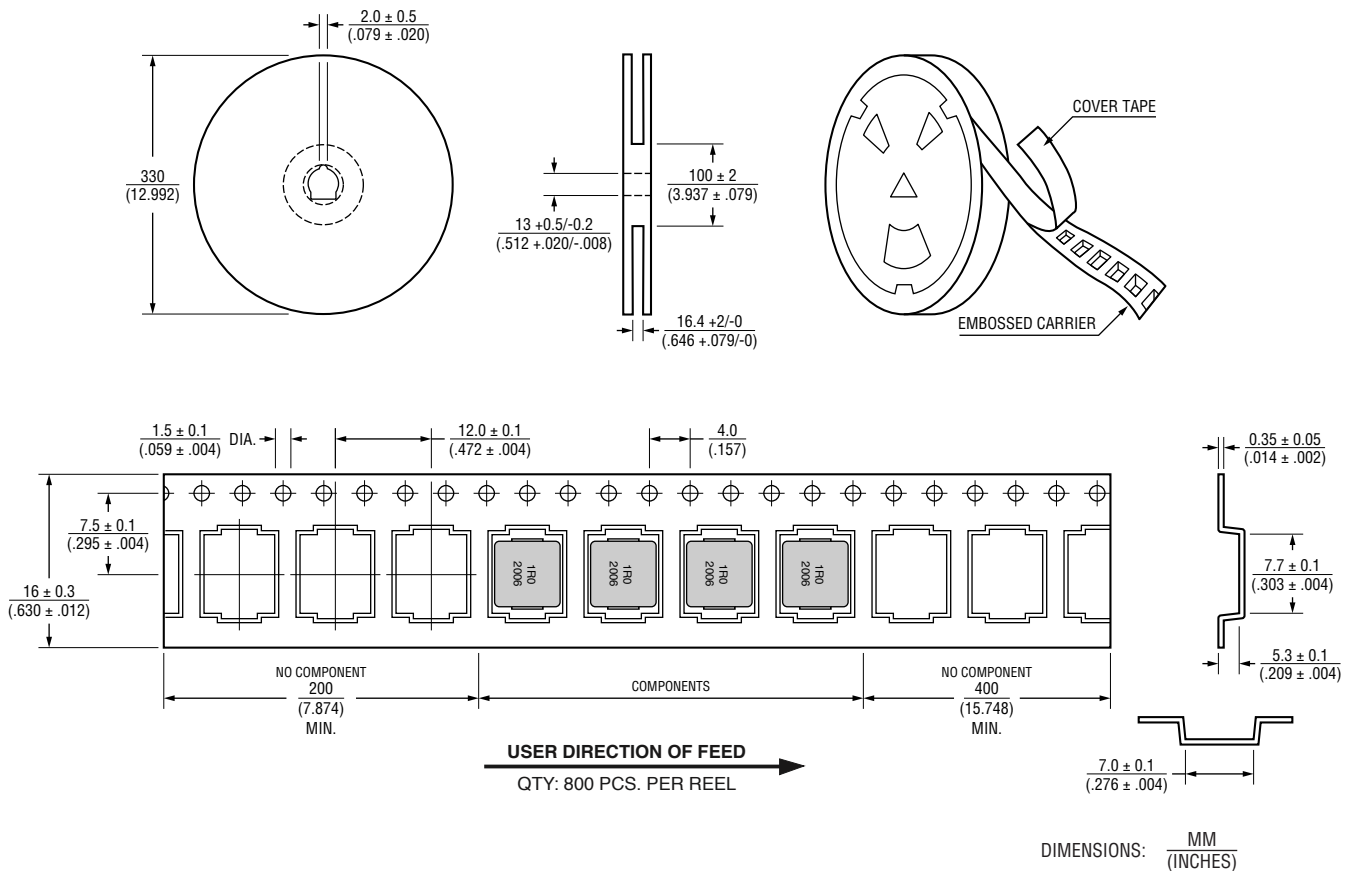
