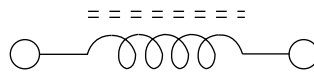

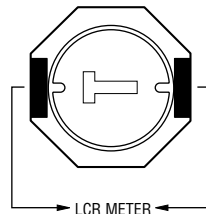

### Inductor Connection



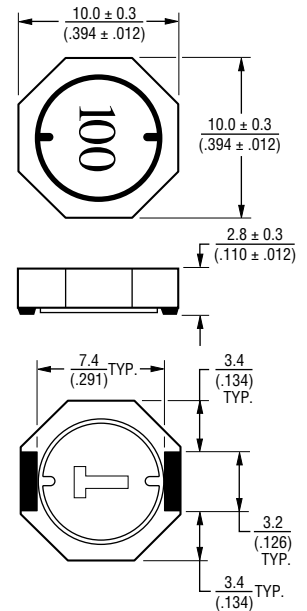
