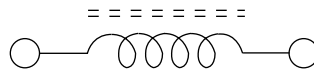

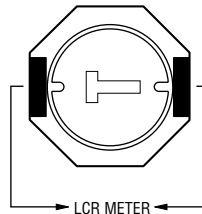

### Inductor Connection



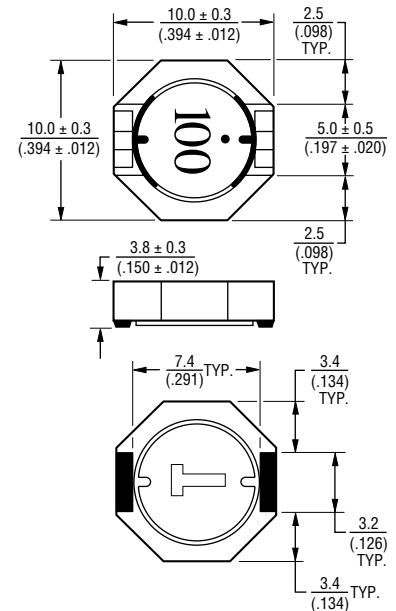

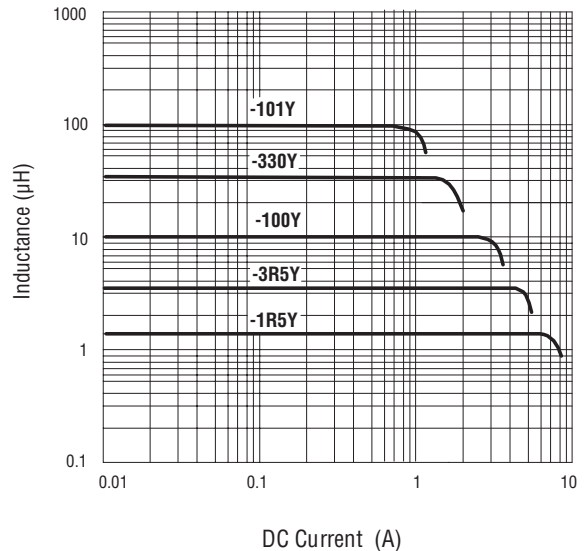

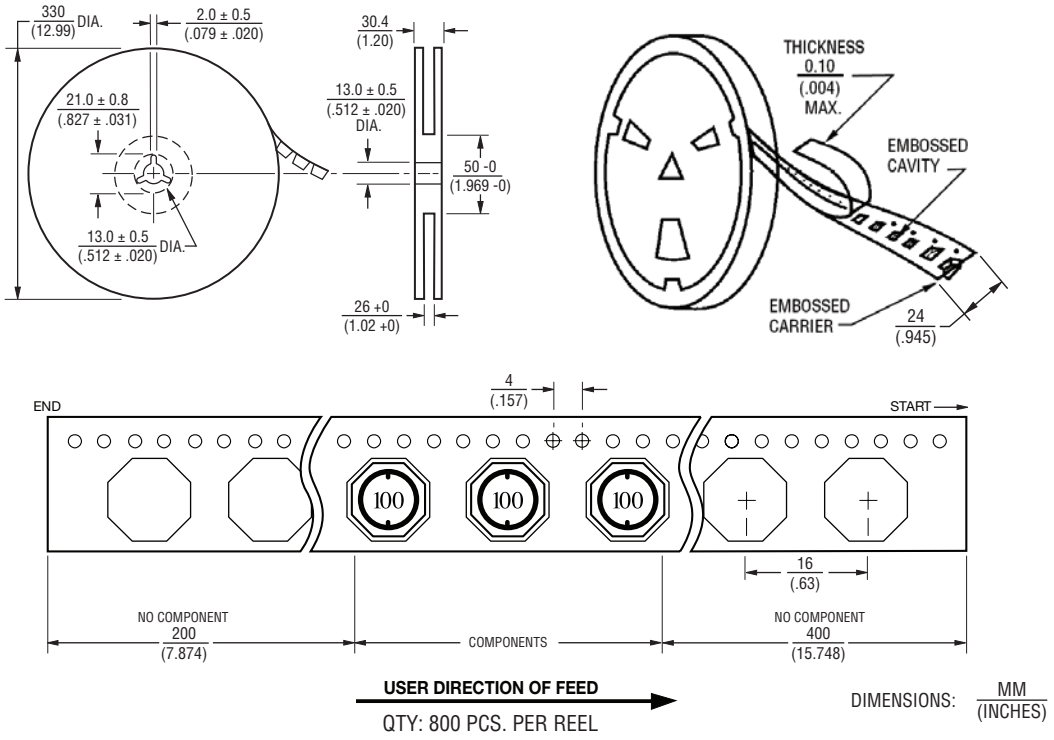
## Soldering Profile
