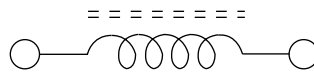

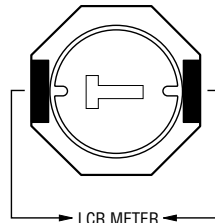

Inductor Connection



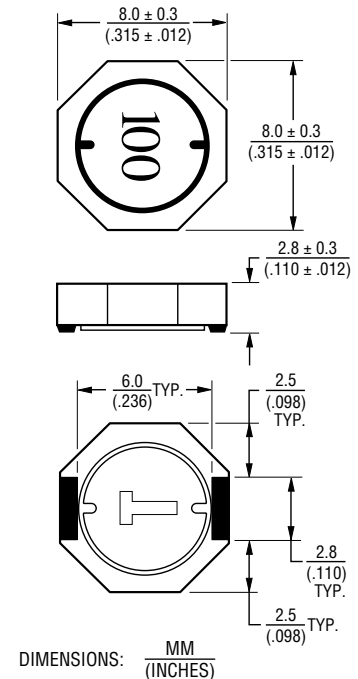

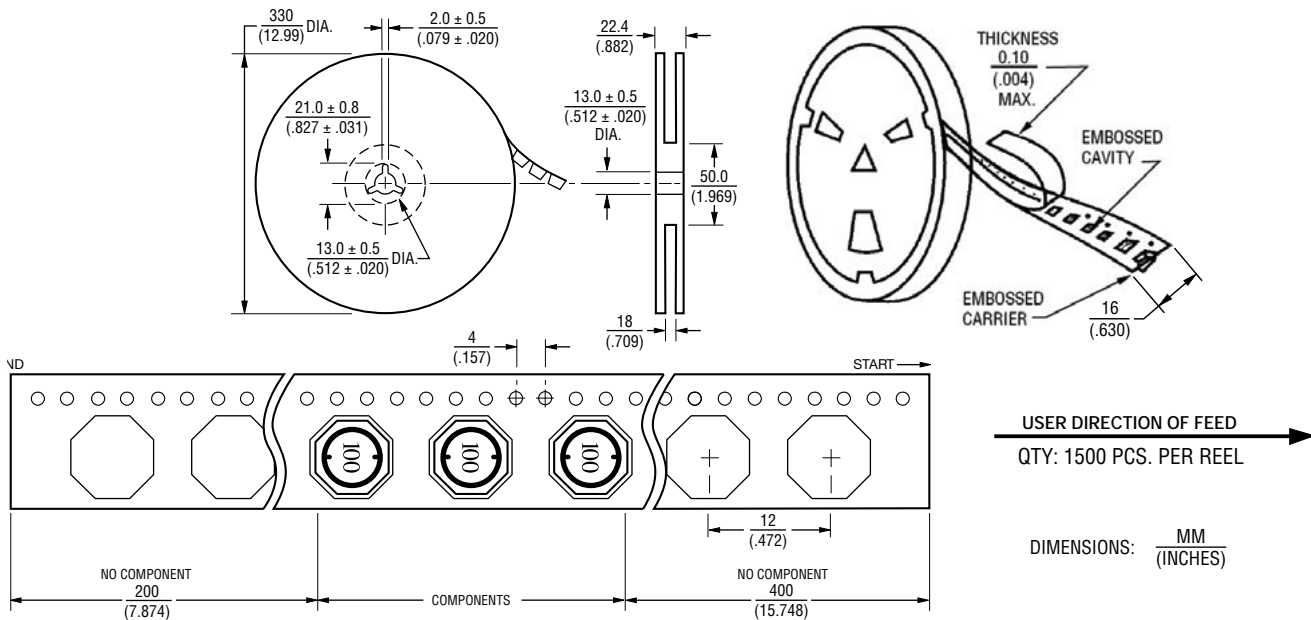
