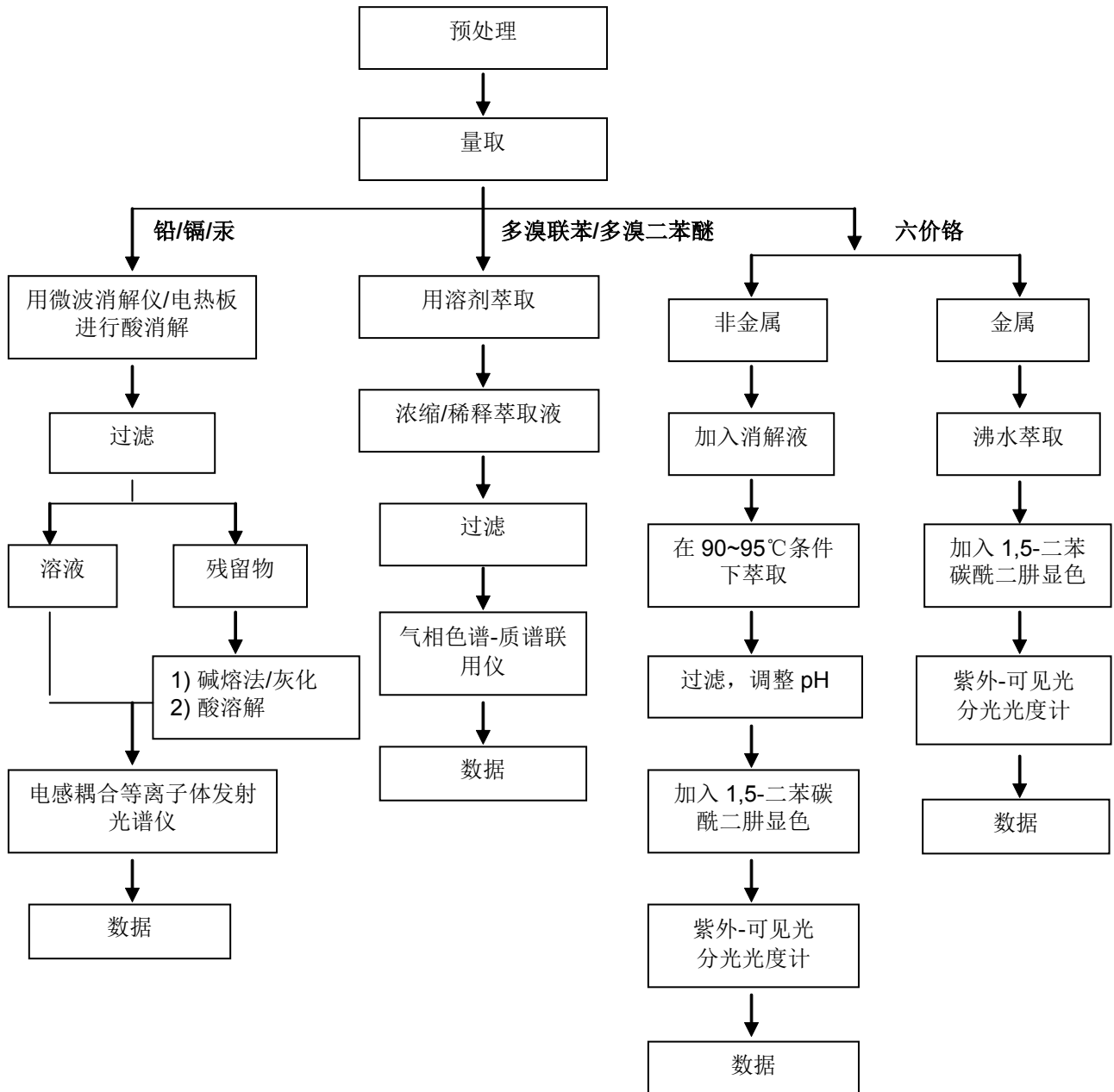

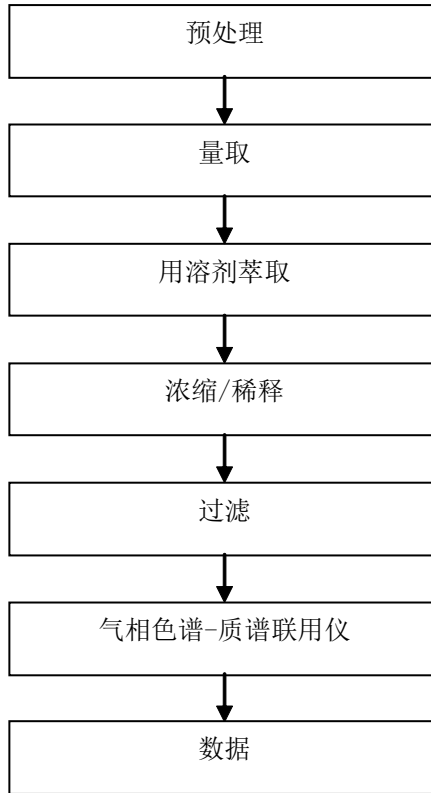

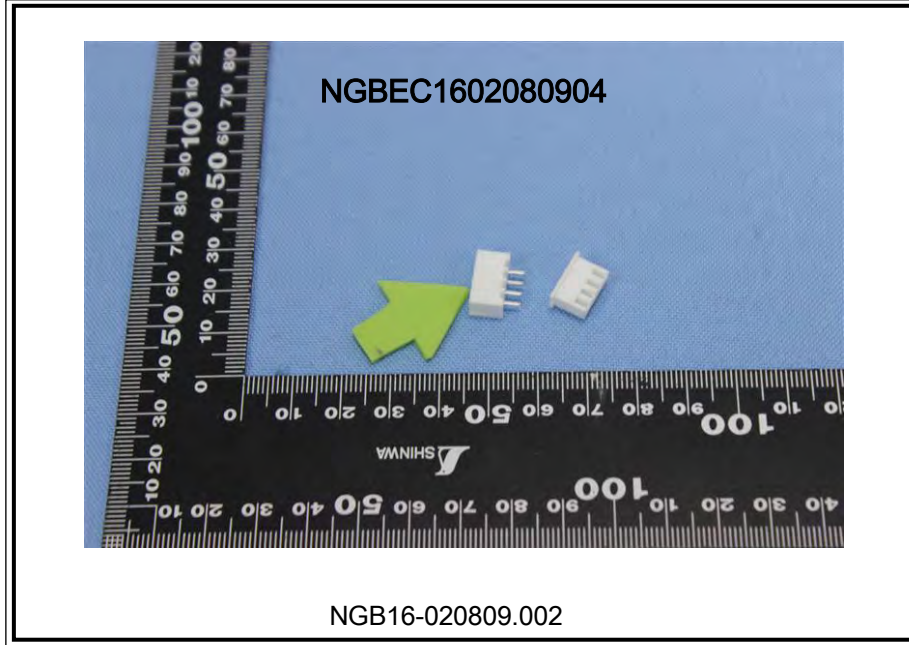

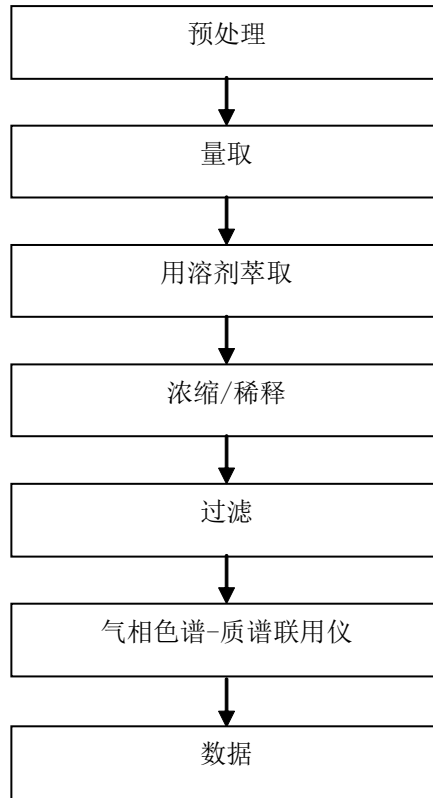

## 多环芳香烃测试流程图

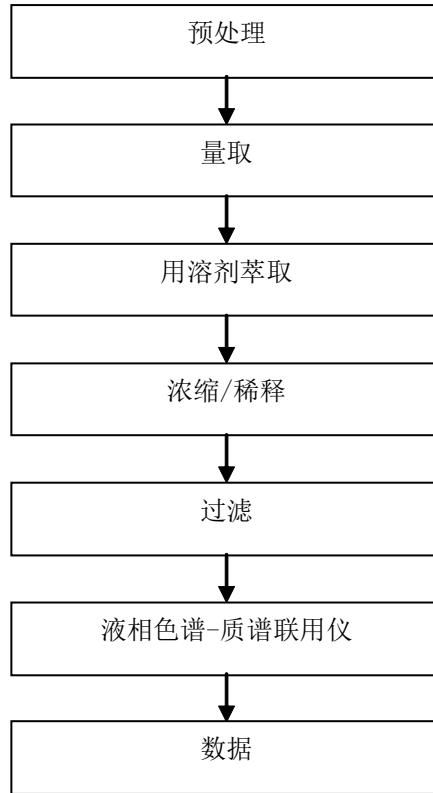

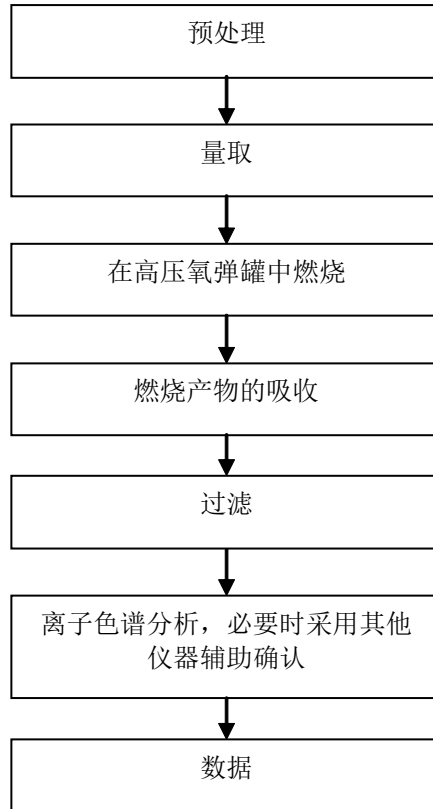
全氟辛烷磺酰基化合物/全氟辛酸测试流程图

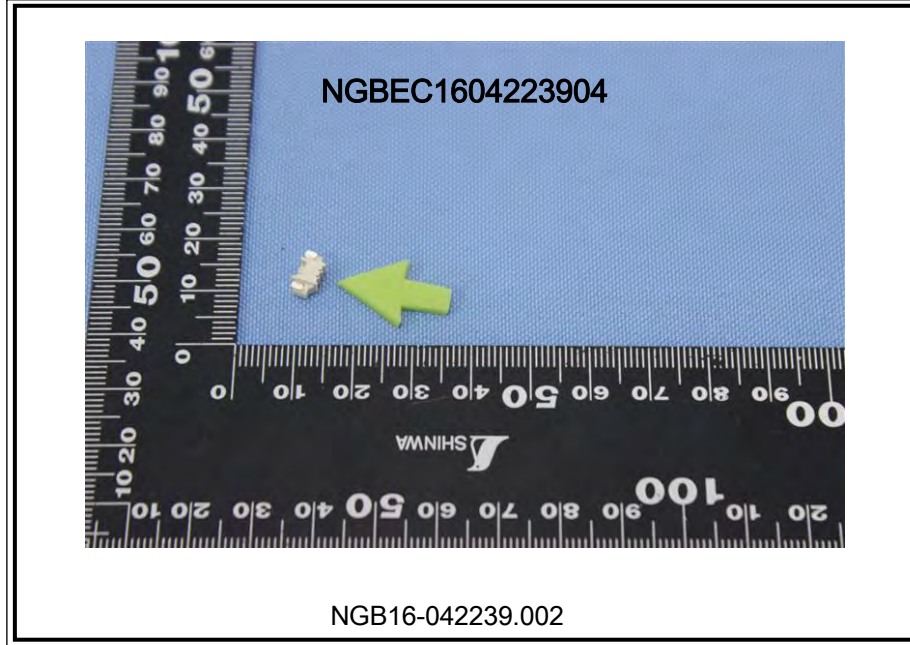
## 邻苯测试流程图

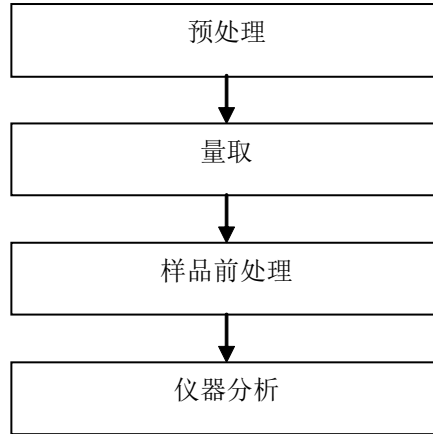
