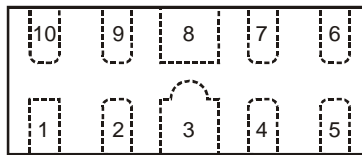

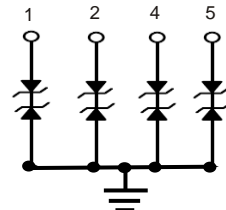

Pin Description (Top View)



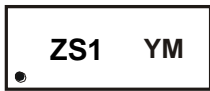

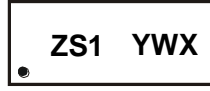

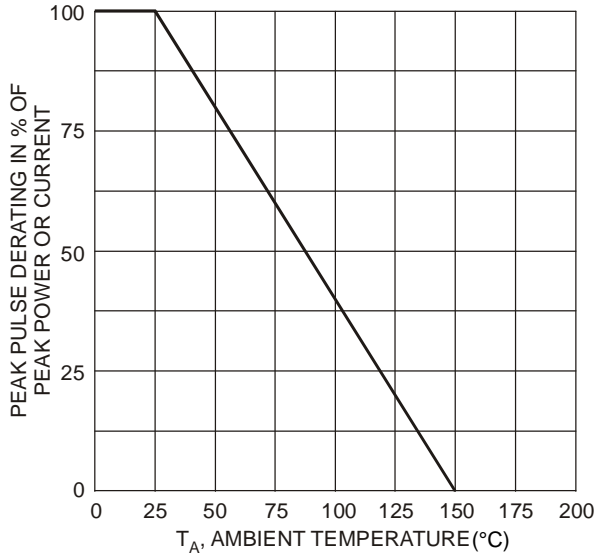


Figure 1 Pulse Derating Curve

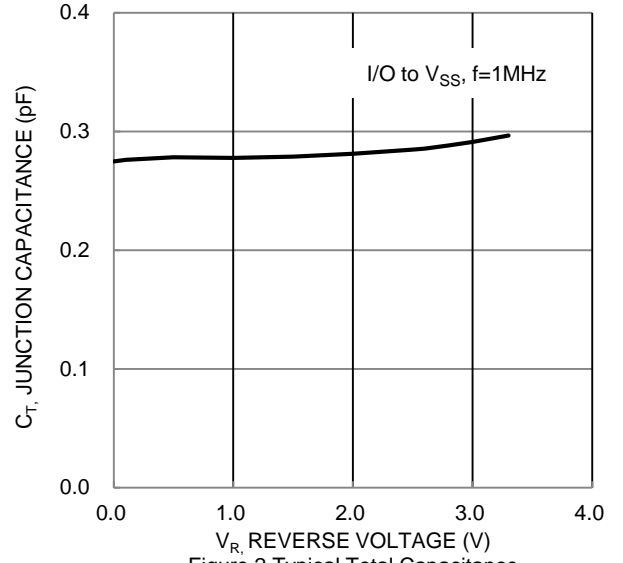


Figure 2 Typical Total Capacitance

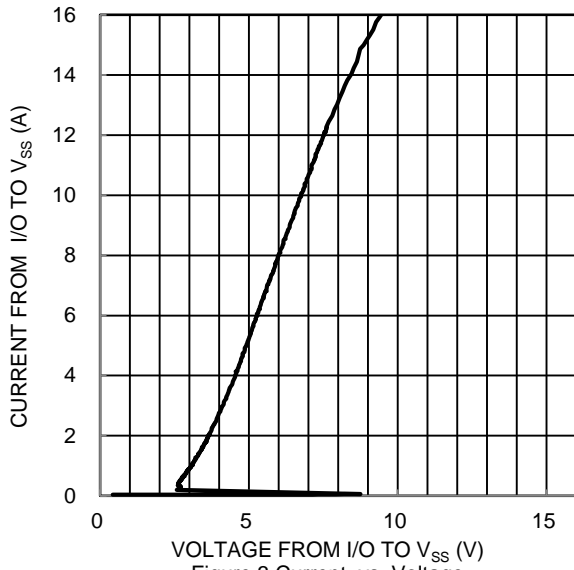


Figure 3 Current vs. Voltage

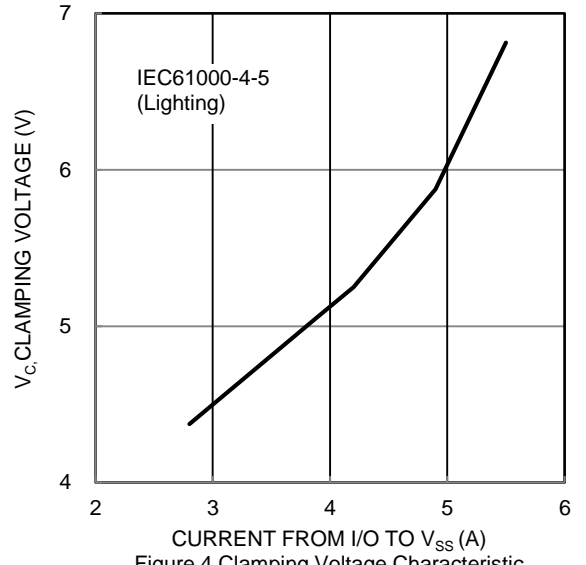
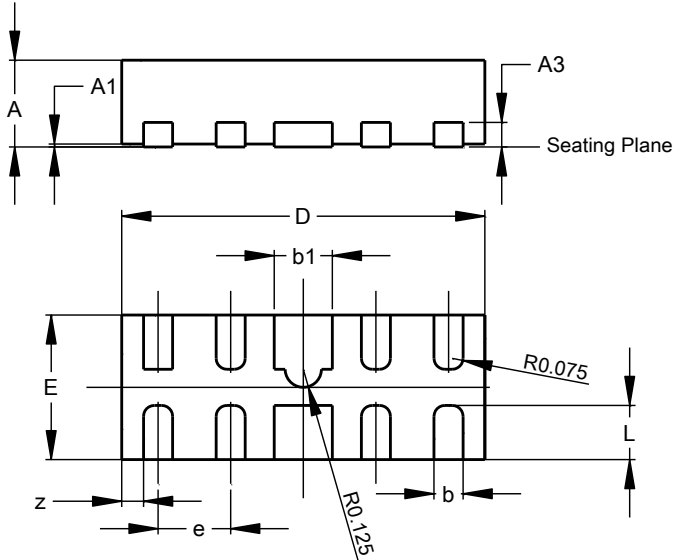


Figure 4 Clamping Voltage Characteristic

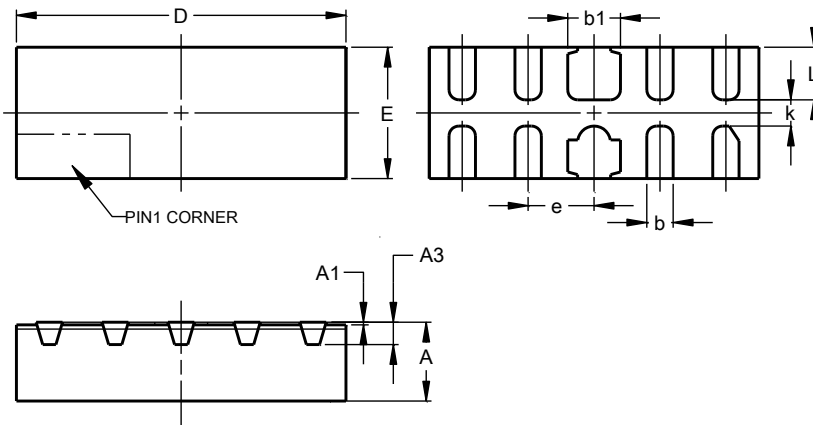

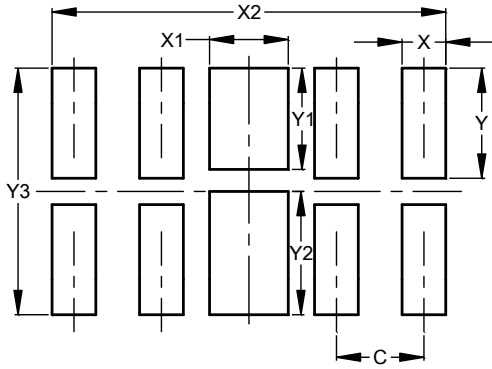

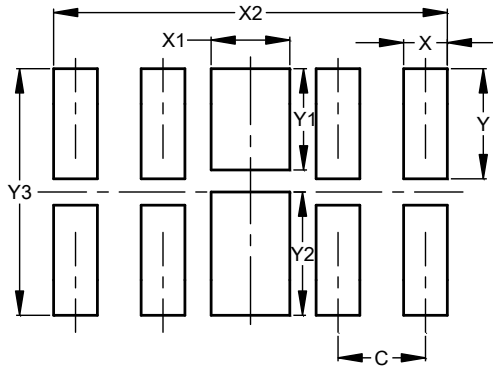
