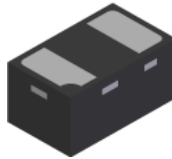

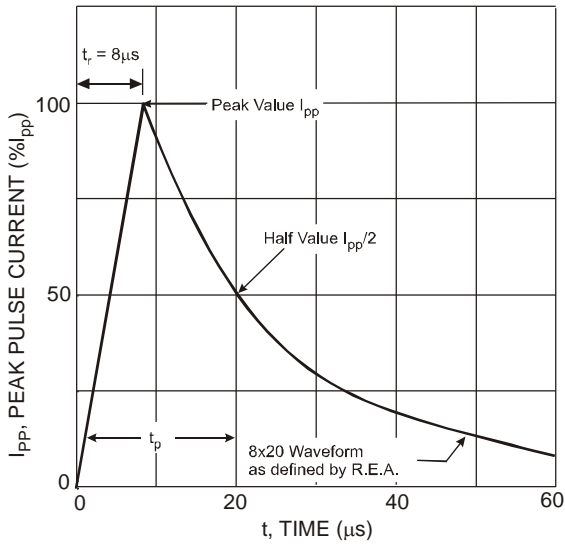


Figure 3 Typical 8 x 20µs Pulse Waveform

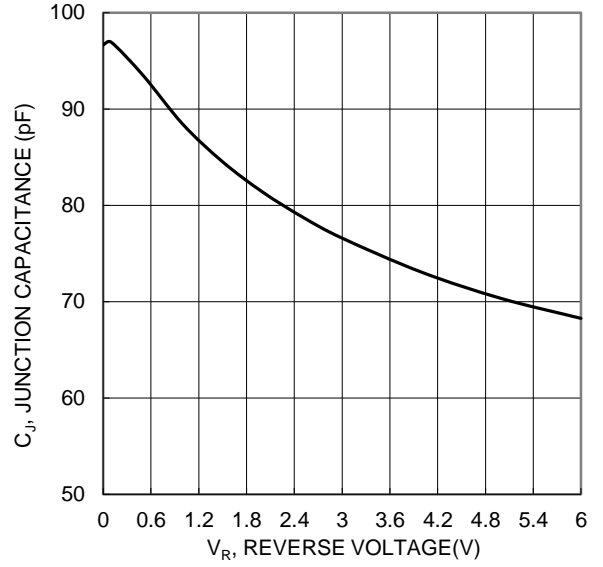


Figure 4 Typical Junction Capacitance

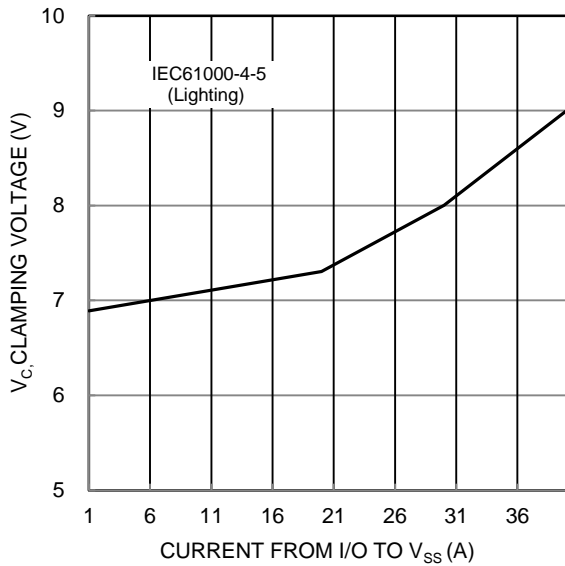


Figure 5 Clamping Voltage Characteristic

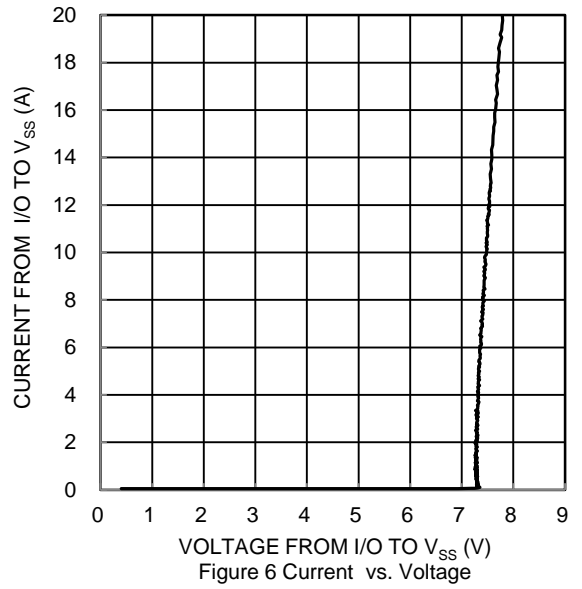
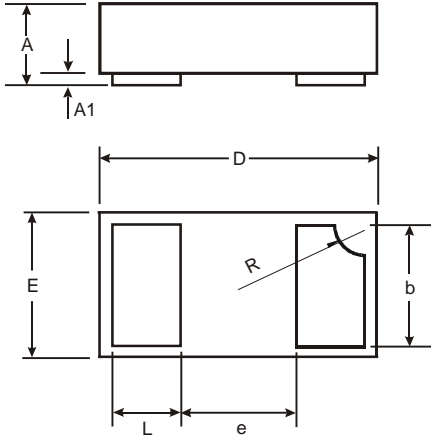


Figure 6 Current vs. Voltage

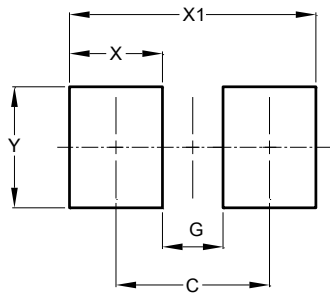
