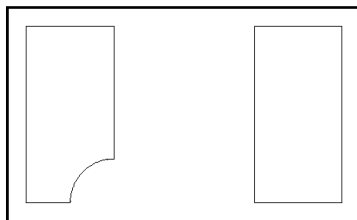

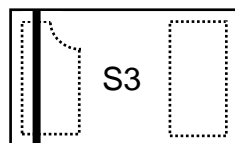
Device Schematic

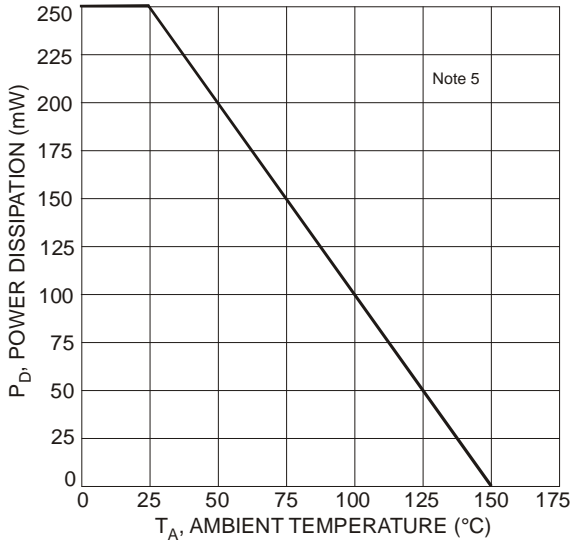


Figure 1 Power Derating Curve

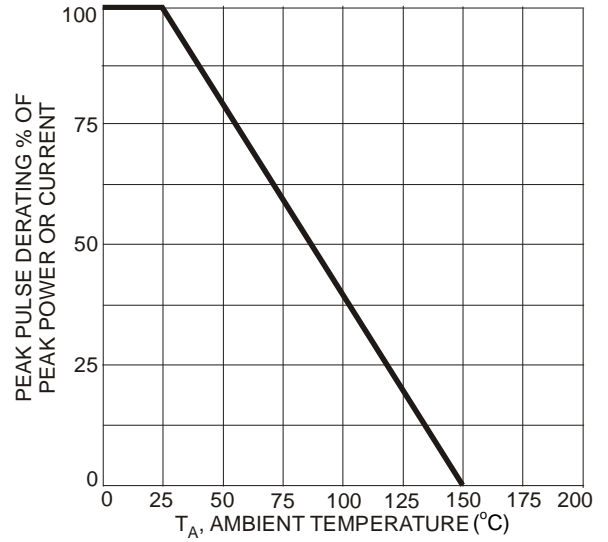


Figure 2 Pulse Derating Curve

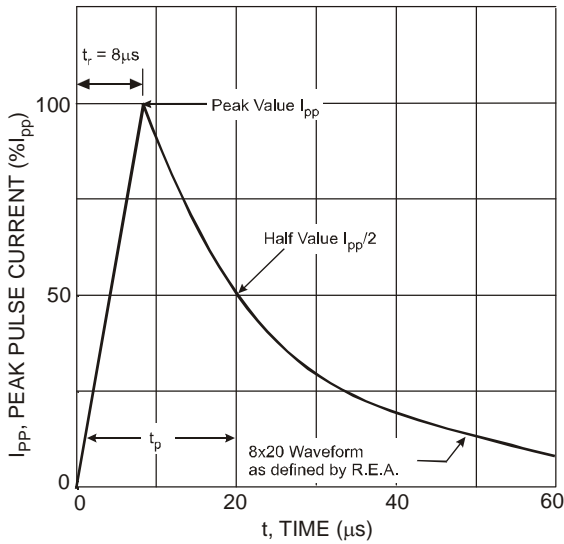


Figure 3 Typical 8 x 20µs Pulse Waveform

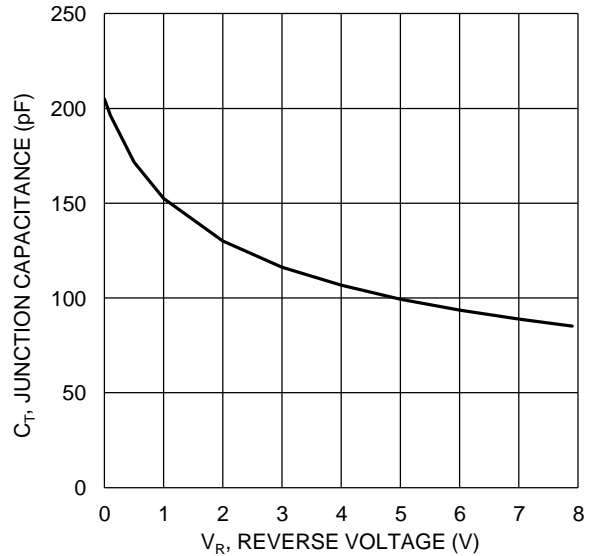


Figure 4 Typical Pin1 to Pin2 Capacitance

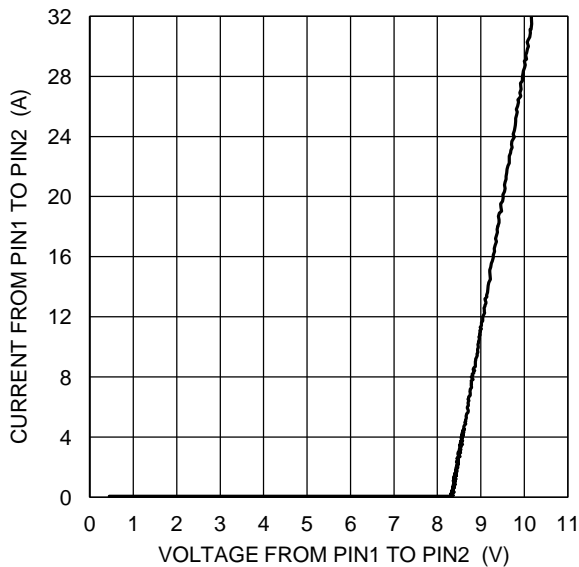


Figure 5 Pin1 to Pin2 TLP Curve

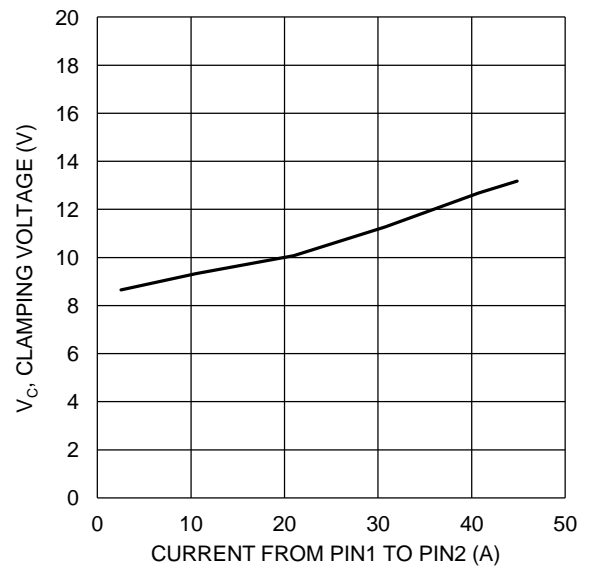
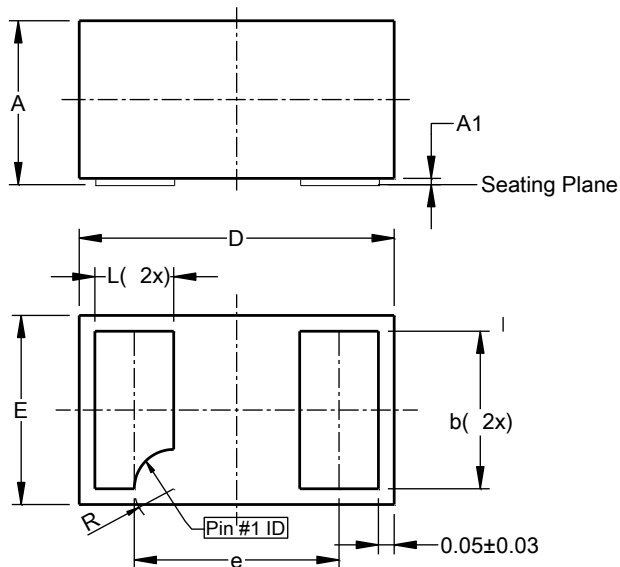


Figure 6 Clamping Voltage Characteristic ($t_p=8/20\mu s$)

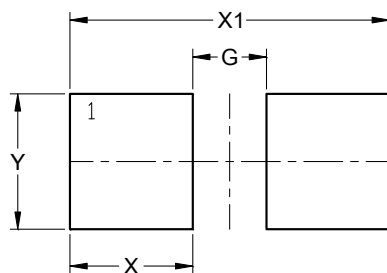
